For the three-month period, the Company has net loss amounted to Baht 415.76 million which is compared with the same period last year shown net loss amounted to Baht 16.48 million For the nine-month period, the Company has net loss amounted to Baht 389.06 million which is compared with the same period last year shown net profit amounted to Baht 390.07 million decreasing of Baht 779.13 million or the rate 199.74 %. 
Net profit

For the nine-month period, the Company has net loss amounted to Baht 389.06 million decreasing from the same period last year amount to Baht 779.13 million or the rate 199.74 % mainly due to:

1. Revenue

The Company has total revenues in the three-month period for the 3rd quarter for year 2022 amounted to Baht 1,077.86 million decreasing of Baht 553.71 million or the rate 33.94 % for the nine- month period shown amount Baht 4,251.78 million when compare the same period last year decrease 519.20million baht or the rate 10.88% because steel industry recession make the price drop resulting in consumers Slow down to see the situation, the price will be the lowest, resulting in the purchase of products as necessary

5.93 million or 33.80%. For the nine-month period in year 2022, financial cost amounted to Baht 54.34

million, which is compared with the same period in last year (Baht 34.85 million), increasing of Baht 19.49

million or 55.91% because the Company has increase in using of letter of credit and trust receipt for

purchasing coil from abroad.





Shareholders' equity as at 30 September 2022 amounted to Baht 1,229.70 million decreasing of Baht 430.24 million or 25.92 %, which is compared with the end of year 2021, due to net loss for this period.
