Service Revenue

Service income decreased from the same period last year by 2.76 million baht or 2.62% from the same

period of last year which shows slight reduction. The reason for this reduction is the continuation of the

realization of project revenue from short term projects in the first half of this year but for the third quarter

realization of revenue has followed the plan.

Cost of Services

The Company and its subsidiaries had increased cost of services by 6.00 million baht from the same

period of last year. or 8.51% from the same period of last year. This resulted from employee benefits and

recruitment of new staff to support the expansion which will would result in the increase of the company's

revenue and subsidiaries in the future.

Administrative expenses

The Company and its subsidiaries had administrative expenses increased by Baht 1.24 million from

the same period of last year. or 6.51% from the same period of last year. This resulted from employee benefits

and expenses of the company. However the company is still controlling and managing the expenses in

accordance with the budget.

Net profit (loss) and net profit (loss) margin

For the three-month period ended September 30, 2022, the Company and its subsidiaries had a net

profit of 12.67 million baht, a decrease of 3.62 million baht from the previous period, representing an increase

in net profit of 22.22% for the same period of last year. The net profit margin is accounted for 12.35% of service

revenue which is relating to the lower income and increased service costs and administrative expenses.

As of September 30, 2022, the Company and its subsidiaries Total assets amounted to 694.67 million baht, an increase of 47.90 million baht from the end of 2021, as a result of an increase in cash and cash equivalents of 45.39 million baht from a decrease of 16.96 million baht in account receivables, and increased short-term loans from financial institutions.

As of September 30, 2022, the Company and its subsidiaries Total liabilities amounted to 367.92 million baht, an increase of 26.15 million baht from the end of 2021. The Company engaged short-term loan from a financial institution which has a low interest rate to reduce the burden of long-term loans with high interest rates and decreased from payment of debt under the finance lease agreement.
