The Board of Directors Meeting of Globlex Holding Management Plc. No. 6/2022, held on November 10, 2022, has approved the reviewed financial statement for Q3 and 9M ended September 30, 2022. In Q3/2022 Globlex Holding Management Plc. and subsidiaries net profit was Baht 6.80 million, an decrease of Baht 18.80 million or -73.44% comparing with net profit Baht 25.60 million for the same period of last year. As for 9M/2022, the net profit was Baht 44.32 million, an decrease of Baht 64.43 million or -59.25% comparing with Baht 108.75 million net profit for the same period of last year.

The Company would like to clarify the reason that the operating results for Q3/2022 and 9M/2022 have changed comparing with the same period of last year as the following;

- 1. Securities brokerage commissions from a subsidiary for Q3/2022 amount Baht 66.68 million, an decrease of Baht 40.12 million or -37.57%. The derivative commissions from a subsidiary amount Baht 6.25 million, a increase of Baht 0.26 million or +4.39%. As for 9M/2022, securities brokerage commissions amount Baht 238.72 million, an decrease of Baht 96.93 million or -28.88%. The derivative commissions from a subsidiary amount Baht 20.40 million, a decrease of Baht 1.31 million or -6.03% from the decrease of trading securities volume.
- 2. Fee and services income from securities from subsidiaries for Q3/2022 amount Baht 35.70 million, an decrease of Baht 48.53 million or -57.61%. As for 9M/2022, fee and services income amount Baht 183.77 million, an decrease of Baht 78.03 million or -29.81%, from decreased income of fixed income products underwrite and arrangement and financial advisor fees.
- 3. Gain and loss from securities and derivative trading from the Company and a subsidiary for Q3/2022 profit amount Baht 4.29 million, an increase of Baht 4.95 million or \pm 749.32%. As for 9M/2022, loss from securities and derivative trading amount Baht 5.68 million, an decrease of Baht 17.98 million or \pm 146.16%.
- 4. The total operating and administrative expenses for Q3/2022 amount Baht 122.68 million, an decrease of Baht 54.10 million or -30.60%. As for 9M/2022 amount Baht 440.32 million, an decrease of Baht 99.27 million or -18.40% from decreased of employee benefit expenses and fees and services, as a result of decreased revenue from securities business.
- 5. Tax expenses from a subsidiary for Q3/2022 amount Baht 2.53 million, an decrease of Baht 5.40 million or -68.07%. As for 9M/2022 Baht 13.24 million, an decrease Baht 16.65 million or -55.71% from the decrease of net profit.
