- 1. Total revenues of the Company decreased 13.12 million Baht or 10.80 % comparing to the same period last year. Shortage of spare parts such as semi-conductor is still has a negative impact for the car market, which results in a decrease in the number of orders from forecast.
- Cost of Sales and Services decreased 6.90 million Baht or 7.36 %, selling and Administrative Expense decreased 1.13 million Baht or 11.27 % comparing to the same period last year. Company has done various activities such as increasing work efficiency, controlling the use of raw materials and consumables resulting in lower expenses when compared with previous year.

Overall, in Q3/FY2022, the Company had net profit around 9.95 million Baht, decreased around 4.99 million Baht or 33.40 % when compared to the same period last year, and recorded earning per share at 0.07 Baht.
