The separate Financial Statement of Home Pottery Public Company Limited ("the Company") for the three-month period ended 30 September 2022 showed total revenue of 71.48 million Baht. This is the highest performance in history. The cost of sales amounted to 47.51 million Baht, while cost of distributions and administrative expenses and financial costs were 9.45 million Baht in total. It was able to return to profit showing a total net profit of 11.64 million baht. The changes are explained as follows.

Sales Revenues:

For the three-month period ended 30 September 2022, the Company generated a revenue from sales of 68.41

million Baht, increasing by 43.60% when compared to the same period in the previous year, which had a total revenue

of 47.64 million Baht. As the epidemic situation of Corona 2019 ("COVID-19") in the customer country is getting better.

Selling export to foreign countries began to return. The company sales volume has increased more than the same

period of 2021. Besides, the income is come from buying-in and selling-out the products according to the customer

request.

Other Revenues:

For the three-month period ended 30 September 2022, the Company generated other revenue of 3.08 million

Baht, increasing by 32.19% from the previous year, which had other revenue of 2.33 million Baht. Due to the company

has gain on currency exchange and been a trading of ceramic home decoration products such as vases jars and pots.

Cost of sales, Cost of distributions and Administrative Expenses:

For the three-month period ended 30 September 2022, the cost of sales was 47.51 million Baht, increasing by

37.51% from the same period in the previous year which had a cost of sales of 34.55 million Baht. The Company's

Gross Profit was 20.90 million Baht which had a Gross Profit Margin of 30.55%, increasing from the same period of

previous year which had a Gross Profit Margin of 27.48%.

For the three-month period ended 30 September 2022, the cost of distributions and administrative expenses

was 9.31 million Baht, increasing from the same period of previous year which had 6.93 million Baht, due to an

increase in distribution costs. Caused by agent commission and products distribution.

Net profit and Net profit margin

For the three-month period ended 30 September 2022, the Company's Net Profit was 11.64 million Baht which

had a Net Profit Margin of 16.28%, increase 55.41% from the same period of the previous year which had Net Profit of

7.49 million Baht. This increase resulted from increased sales volume and lower average cost of sale compared to the

same period last year Thus affecting the recognition of revenue, profits and increased profit margins.

The consolidated financial statements in the three-month period ended 30 September 2022, show total sales

revenue of 83.85 million baht, cost of sales of 59.31 million baht and show net profit for the period of 12.93 million baht,

with increased profits from the previous year. Because the company and its subsidiaries has adjusted its strategies

and promoted marketing both domestically and internationally. And the company received more orders from foreign

countries which are main market. Because world had recovered from covid-19 pandemic.
