According to the Board of Directors' meeting of NCL International Logistics Public Company Limited (the "Company" or "NCL") No. 7/2022 on October 27, 2022, it was resolved that the Company shall purchase of the ordinary shares of Asia Wealth Securities Company Limited, ("AWS"), in the proportion of 60 percent of the paid-up capital AWS from the paid-up capital of 444,903,800 baht at a par value of 10 baht per share, representing 26,694,228 shares purchased in price Thai baht 13.9356 per share, amounting to Thai baht 372,000,000.- by purchasing the shares from Asia Wealth Holding Company Limited ("AWH" or the "Seller"). The share purchase agreement is signed on November 4, 2022. AWH is not a connected person of the Company. The acquisition of AWS shares is made together with eight other individual persons who are not connected persons of the Company, who shall acquire the remaining 40% of AWS shares. The Company will pay for the acquisition in cash. After the transaction, AWS will become a subsidiary of the Company.

Entering into such transactions are considered an asset acquisition according to the Notification of the Capital Market Supervisory Board No. Tor Jor 20/2008 Re: Rules on Entering into Material Transactions Deemed as Acquisition or Disposition of (and as amended) and the Notification of the Board of Governors of the Stock Exchange of Thailand Re: Disclosure of Information and Practices of Listed Companies Concerning the Acquisition or Disposition of Assets, 2004. The value of transaction is calculated to be 37.94%, the maximum transaction size as calculated on the Net Tangible Assets ("NTA") basis. The Company does not have any asset acquisition transaction that occurred during the past 6 months. The total asset acquisition transaction size is the highest equal to 37.94% based on the value of assets (NTA) criteria, which falls in the transaction size of more than 15% but less than 50%. Therefore, this acquisition of AWS ordinary shares is considered a Type 2 transaction according to the Notification of the Board of Governors of the Stock Exchange of Thailand Re: Disclosure of Information and Practices of Listed Companies in the Stock Exchange of Thailand 2004 (Acquisition and Disposition Notification). The Company has a duty to disclose information about the transaction of the Company to the Stock Exchange of Thailand and send a letter notifying the shareholders about the Company's execution of the said transaction. within 21 days from the date of disclosure of the transaction to the SET

Information Memorandum on Acquisition of Assets of NCL International Logistics Public Company Limited (Information Memorandum 1)

The Board of Directors Meeting of NCL International Logistics Public Company Limited (the “Company” or “NCL”) No. 7/22 on October 27, 2022, it was resolved to approve the Company to acquire 60% of the paid-up capital of Asia Wealth Securities Company Limited, (“AWS”). The Company agreed to purchase 26,694,228 shares at Thai baht 13.9356 per share for a total amount of Thai baht 372,000,000.- from Asia Wealth Holding Company Limited (“AWH” or the “Seller”), in the proportion of 60 percent of the paid-up capital AWS from the paid-up capital of 444,903,800 baht at a par value of 10 baht per share. The share purchase agreement is signed on November 4, 2022. AWH is not a connected person of the Company. The acquisition of AWS shares is made together with **eight** other individual persons who are not connected persons of the Company, who shall acquire the remaining 40% of AWS shares. The Company will pay for the acquisition in cash. After the transaction, AWS will become a subsidiary of the Company.

1 Transaction Date

The Company has signed a share purchase agreement on November 4, 2022. The transfer of ownership of AWS shares and payment will be executed upon the fulfilment of the conditions precedent of the transaction specified in the share purchase agreement. The acquisition is expected to be completed by no later than December 30, 2022.

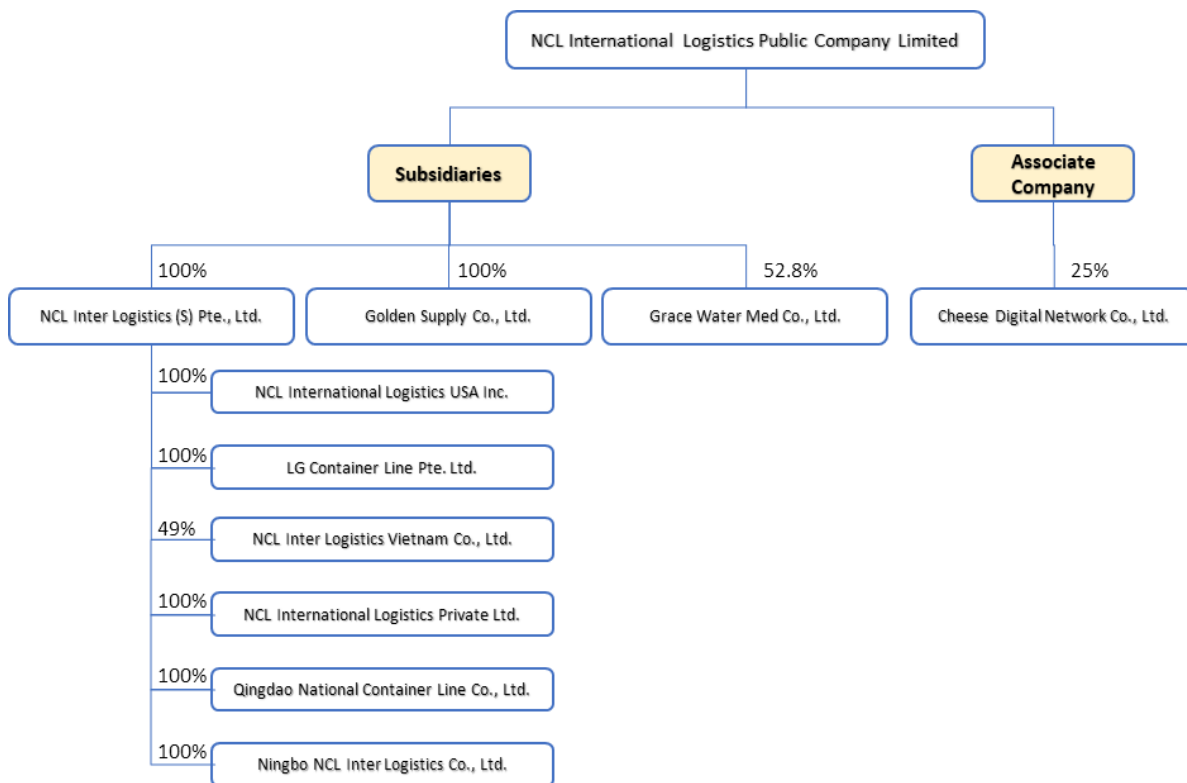

3 General Characteristics of the Transaction and Transaction Size

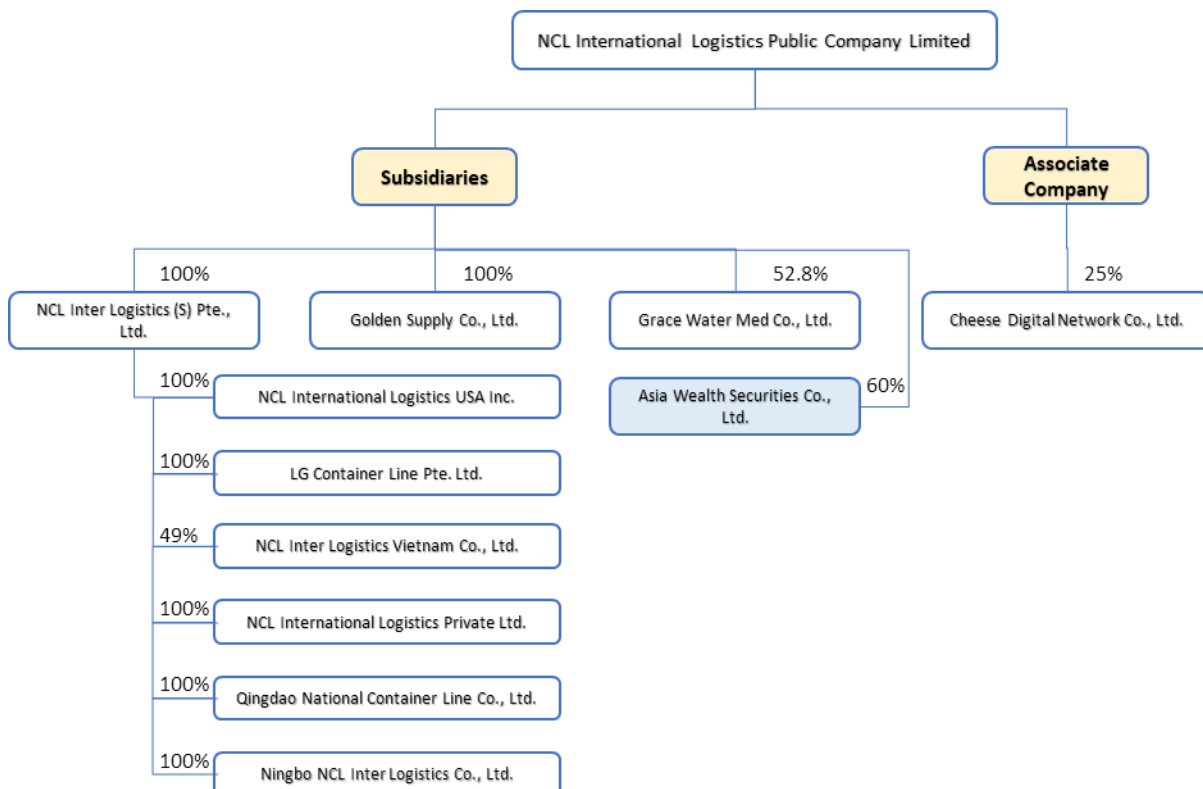
3.1 General Characteristics of the Transaction

The Company will purchase AWS common shares as detailed above. After the purchase of shares is completed, NCL's business structure is as follows:

For the management policy in AWS, the Company shall appoint a new board of director to be not less than half of the total board member. Mr. Pongthep Vichaikul, **Managing Director of NCL** will be appointed as the Chairman of the Executive Committee of AWS to oversee management decisions. Moreover, the current management, who are professional executives, shall be retained for at least two years after the acquisition. The Company will control the operations through the Board of Directors and the Executive Committee.

3.2 Transaction Size Calculations

The calculation of the transaction size according to the acquisition/disposal of assets criteria based on the Company's consolidated financial statements as of June 30, 2022, which is the latest consolidated financial statements that have been reviewed by the Company's auditors prior to the date that the Board of Directors has approved the acquisition of ordinary shares of AWS. 5 Value of Assets Acquired

After the acquisition, the Company will be the largest shareholder of AWS, which has a total asset value as of the audited accounts ended June 30, 2022 equal to THB 652.09 million.

6 Total Value of Consideration and Criteria Used to Determine Total Value of Consideration

6.1 Total Value of Consideration

This acquisition of AWS shares has a total consideration of THB 372,000,000.- as the details have been mentioned above.

6.2 Criteria Used to Determine the Total Value of Consideration

The Company determined the price of the purchase of AWS common shares for a total of THB 372,000,000.-, which the criteria for consideration were determined from the negotiation between the buyer and the seller by considering the fair value of the shares which the management of the Company together with the financial advisor, **Synsujarit Co., Ltd. by Sujarit Isarankura, the financial advisor that has been approved by the SEC**, to evaluate the share value according to various financial valuation methodologies and determined that the appropriate share value should be based on the Discounted Cash Flows Approach, which should more accurately reflect the capabilities and future performance of AWS. The fair value of AWS at 60% is valued at approximately THB 418.30 million.

7 Expected Benefits to the Company

1. As this transaction is a purchase of more than 50% of AWS ' shares, AWS will become a subsidiary of the Company. The Company shall recognize the income from AWS immediately after successful transaction.
2. It is a diversification of business risks by investing in other businesses besides the logistics business in which the Company currently operates.
3. It is an investment in the securities business during the time when the stock market is in a trough caused by the COVID-19 crisis. Therefore, it is expected that the securities business will return to the uptrend after the crisis is over and return to profitability which will make maximize the return to the Company.

8 Source of Funds Used to Purchase Assets

For funding to acquire 60% of AWS, Thai baht 372,000,000.- shall come from the issuance of debentures issued according to the resolution of the Extraordinary General Meeting of Shareholders No. 2/2022 held on July 26, 2022 in the amount of THB 500,000,000.-, which is in the process of applying for an approval from the Office of the Securities and Exchange Commission.

9 Conditions for the Transaction

9.1 Conditions Precedent

The material conditions precedent are as follows:

1. The Office of the Securities and Exchange shall approve NCL becoming the shareholder of AWS and the appointment of the persons nominated by NCL as directors of AWS.
2. The Seller shall cause AWS to sign a management agreement with Mr. Chanachai Juljiraporn for a period of at least 2 years after the successful completion of the Acquisition.
3. The Seller shall remove all pledges of all the shares of AWS and disclose to NCL and the pledgee of the removal from AWS's share registration book and deliver the actual execution copy of the letter accompanied with the pledgee's signatures and deliver the share certificates to NCL for consideration.
4. The Seller shall fulfill the conditions specified in the share purchase agreement and other agreements related to the purchase.

9.2 Material Conditions After Acquisition

1. After the Company performed due diligence on AWS, it was confirmed that AWS has a civil court and appeal court judgment, such that AWS is liable to pay damages to a plaintiff. The case is currently on appeal to the Supreme Court of Thailand ("San Dika"), however, it is likely that AWS will have to pay damages to the plaintiff in the amount of THB 23,000,000.-. As a part of the Acquisition, NCL will receive cash collateral for the amount in the proportion of the 60% shareholding acquisition, which amounts to THB 13,800,000.-.

On the day the Acquisition is completed, the Seller agrees to place the aforementioned cash collateral to NCL to compensate for potential damages related to the lawsuit arising prior to the completion date as specified in the share purchase agreement as well as any fine from events occurring prior to the completion date as related to AWS insufficient liquidity risk management

and/or AWS's net liquidity capital calculation and maintenance that was below the law requirement, in the case where AWS is a defendant in the lawsuit. NCL shall be able to deduct such amount from the payment of the purchase price.

In the event that the damage value is lower than the collateral amount in the lawsuit (only the judgment amount for the cases with the final judgment as related to only AWS), NCL shall deliver the difference between the collateral amount and the damages payable to the plaintiff and return the balance to the Seller within three business days.

In the case of the above collateral is insufficient to pay for the damages arising from any lawsuits or fines in relation to AWS insufficient liquidity risk management and/or AWS's net liquidity capital calculation and maintenance that was below the requirement by law, NCL shall have the right to claim damages for the difference between the damages according to the final judgment or the fines levied against AWS and the collateral value.

2. In civil case with another plaintiff, in which the verdict is not apparent, NCL stipulated that the Seller deposit a letter of guarantee issued by a financial institution for the amount in the proportion of the 60% shareholding acquisition, which amounts to THB 10,800,000.- from the estimated total damage claim in the lawsuit of around THB 18,000,000.-.

On the day the Acquisition is completed, the Seller agrees to place the aforementioned collateral in the form of a letter of guarantee issued by a financial institution with a validity of at least 2 years from the date of completion of the purchase to the buyer as collateral for compensation for damages arising from the lawsuits. In the event that the letter of guarantee expires before the final judgment in the above case, the Seller agrees to bring a new letter of guarantee with a limit and a period of not less than the original to place it with the buyer until such a case reach a final verdict.

In the event that the damage is less than the value of the letter of guarantee, NCL shall have the right to demand the bank to pay the letter of guarantee equal to the damages payable to the plaintiff or in the event that the Seller pays such damages to the buyer directly, NCL shall return the letter of guarantee to the Seller within three working days.

In the event that the bank guarantee is not sufficient to pay damages to the plaintiff, NCL shall have the right to claim damages for the difference between the damages according to the final judgment and the value in the letter of guarantee.

3. As Asia Wealth Holding Company Limited (AWH) or the Seller has a loan that has to be repaid to AWS amounting to THB 196,361,929.39. Therefore, within the next business day following the completion date of the Transaction, the Seller must repay the aforementioned loan including any other liabilities due to AWS in the amount of Thai baht 196,361,929.39 (Thai baht one hundred ninety-six million three hundred sixty-one thousand nine hundred twenty-nine and thirty-nine satang) to AWS by a cheque or by any other means as notified to the Buyer the prior to the completion of the Transaction and deliver the said cheque to the Buyer on the date of completion of the Transaction as proof of payment to the Buyer and the Buyer shall cause the Company to issue a receipt of such payment to the Seller within the next business day after receiving such payment.

10 Opinion of the Board of Directors Regarding the Transaction

It is the opinion of the Board of Directors that the acquisition of ordinary shares of AWS, a securities company, is consistent with the Company's business plan, which is to diversify into other businesses that mitigate the business cycle of the core logistics business. From the current situation whereby many businesses are affected by the epidemic of COVID-19, the valuation of the acquisition is valued based on the current environment that remains repressed under the impact of COVID-19. As the COVID-19 risk subsides, it is likely that the acquisition price of such business will be at a substantial premium to the approved acquisition price. In addition, the acquisition price is lower than the fair value calculation by the financial advisor and the Company's management. The Board of Directors has the

opinion that this investment will create added value and diversify risks in the Company's business in the future. Therefore, the Board of Director has resolved to approve to the transaction.

11 Opinion of the Audit Committee and/or the Company's Directors with Different Opinions from the Board of Directors

The Audit Committee's opinion is consistent with the Board of Directors above.
