Distribution Costs and Administrative expenses

In the third quarter 2022, the distribution costs at Baht 123.5 million, increased Baht 75.7 million or 158.1 % compared to the same period of the year 2021

In the third quarter 2022, the administrative expenses at Baht 69.1 million, increased Baht 5.2 million or 8.1 % compared to the same period of the year 2021 However, The increasing of expenses because of increase on the revenue from transfer of land and houses

Financial expenses

In the third quarter 2022, The company and subsidiaries had expenses at Baht 22.8 million, decrease Baht 1.0 million or 4.5 %, compared to the period of the year 2021. Most of them are interest on defaulted debts.
