Consolidated financial performance

The Company and its subsidiaries had sales revenue for the third quarter of 2022 of 601.50 million baht, compared to 2021 in the same period, an increase of 248.77 million baht or an increase of 70.53 percent. The change in main income came from T S Flour Mill Public Company Limited (a subsidiary) which had an increase in sales revenue of 187.79 million baht, and in the third quarter of 2022, T S Food Holding Company Limited (a subsidiary) bought ordinary shares of Nature Best Food Company Limited, causing the Company to recognize revenue from the sale of seaweed products for 78.41 million baht.

Revenue from rental and services in the third quarter of 2022 amounted to 88.02 million baht, compared to the year 2021 in the same period decreased by 2.22 million baht or 2.46 percent. The change in main income came from T S Transport and Logistics Company Limited (a subsidiary) which had a decrease in berth-net revenue of 2 7 .2 8 million baht and an increase in revenue from packing contracts of 24.35 million baht.



The cost of sales in the third quarter of 2022 amounted to 487.97 million baht, compared to 2021 in the same period, an increase of 200.43 million baht or an increase of 69.70 percent.

The cost of rental and services in the third quarter of 2022 amounted to 61.61 million baht, compared to 2021, which decreased by 0.42 million baht or 0.67 percent.

Summary of consolidated financial performance in the third quarter of 2022

The Company had a net profit of 49.08 million baht, compared to the year 2021. In the same period, the Company had a net profit of 29.23 million baht. The Company's net profit increased by 19.85 million baht or an increase of 67.91 percent.

Important factors are as follows:

1. In the third quarter of 2022, the Company invested in T S Food Holding Company Limited (a subsidiary), which is a holding business by holding 100 percent and this subsidiary bought ordinary shares of Nature Best Food Company Limited, a food business. The Company has increased net profit from this Company in the amount of 11.12 million baht.

2. T S Flour Mill Public Company Limited (a subsidiary) reported an increase in net profit of 16.93 million baht or 75.30 percent.

As at September 30, 2022, the Company had total assets of 5,988.45 million baht, total liabilities of 1,959.56 million baht, and shareholders' equity of 4,028.89 million baht, with a debt-to-equity ratio (D/E Ratio) of 0.49. Interest to Equity (Interest-Bearing D/E Ratio) was 0.33
