Begistics Public Company Limited (the "Company") would like to submit the financial statements for the threemonth period ended September 30, 2022 with the Company's operating results compared to the same period last year. We would like to summarize the key points of the operating results as follows:

## <u>Revenue</u>

The Company has total revenue for the three-month period ended September 30, 2022 and 2021, 59.33 million baht and 79.59 million baht respectively. Decreasing from 2021 by 20.26 million baht or 25.46 percent compared to the third quarter of 2021.

The Company had another income in the third quarter of 2022 equal to 27.07 million baht from the foreign exchange rate profit 15.21 million baht.

## <u>Cost</u>

The Company has total expenses for the three-month period ended September 30, 2022 amounted 56.13 million baht, decrease of 17.84 million baht or 24.12 percent from last year due to growth in the same direction as revenue.

## Net profit

In the third quarter ended September 30, 2022. The Company had a net profit of 5.14 million baht, decrease of 5.76 million baht or 51.55 percent as a result of profits from the profit sharing from associated companies reduce from 5.86 million baht in year 2021 to 3.11 million baht in 2022.

<u>Asset</u>

The Company's total assets in the third quarter ended September 30, 2022 amounted to 2,373.19 million baht, an increase of 1,019.97 million baht from the previous year or 75.37 percent, caused by an investment in the purchase of 29 trucks to expand the logistics business, including an investment in The Megawatt Company Limited (Associated Company) and an additional investment in the raw water business, Theprittha Co., Ltd.

### <u>Debt</u>

The Company's total liabilities in the third quarter ended September 30, 2022 amounted 241.39 million baht, an increment of 63.21 million baht from the previous year or 35.48 percent due to increment by 73.91 million baht in liabilities under the lease – net and trade accounts payable and payable.

#### **Equity**

The Company sells newly issued ordinary shares ("RO") together with warrants to purchase the ordinary shares of Begistics Public Company Limited No. 7 ("B-W7") total 3,460,259,199 shares, resulting in the Company's shareholders' equity in the third quarter ended September 30, 2022 amounting to 2,131.80 million baht, an increment from the same quarter in 2021 of 956.75 million baht or equivalent to 81.42 percent.
