 - 2. Profit margin decreased to 17.07% as compared with the same period of prior year which was 21.83% because of raw material's price increased.
 - 3. Selling expenses increased to 1.64 Million Baht or by 15.44% because of the revenue from sales increased.
 - 4. Administrative expenses increased because TGPRO has recorded the doubtful debt allowance under TFRS #9 and depreciation
