2022 financial statements, the company had a net profit of 40.627 million baht, compared to the 2021 financial statement of 55.242 million baht, a decrease of 14.615 million baht or 26.46 % with the cause as followings.





1. Sales Revenue and Cost of Goods sold

Company's sales revenue for the financial statements of 2022 as 31 December 2022 was

757.085 million baht compared to Financial statements year 2021 was 684.097 million baht. The company's sales revenue in 2022 increased by 72.988 million baht, or 10.67% with increased revenue caused by

- The increasing in the number of new customers
- The increasing of product price
- Sales Revenue of Surin branch increased

The cost of goods sold in the 2022 financial statements as December 31,2022 was 640.836 million baht compared to the 2021 financial statements of 555.131 million baht with the company's cost of goods sold increased by 85.705 million baht or 15.44% due to the increasing in raw material prices.

2. Other income

The Company's other income increased by 72.48 % which was income from interest income profit from sale of assets and plastic scrap.

3. Gross profit

Gross profit for the 2022 financial statements as of December 31,2022 as 118.236 million baht for the financial statements for the year 2021, it was 130.118 million baht, a decrease of 11.882 million baht or 9.13 % due to the increase in cost of goods sold following the increase in raw material prices.

4. Selling Expenses

Selling Expenses for the 2022 financial statements was 23.449 million baht compared to the 2021 financial statements was 23.269 million baht, an increase of 0.18 million baht or 0.77% from the increase in transportation costs.

5. Administrative Expenses

Administrative Expenses for the year 2022 financial statements was 41.017 million baht compared to the year 2021 financial statements was 37.237 million baht, an increase of 3.78 million baht or 10.15 % from an increase in wages and provision for doubtful debts

Overall performance in 2022 the company was affected by the price of main raw materials increased. In addition, transportation costs and wages have increased. As a result in 2022, the Company's performance results were lower than the previous year.
