Metro Systems Corporation Public Company Limited would like to clarify the operation results of consolidated financial statements for the year ended December 31, 2022 as follows;

In the year 2022, the company had revenue from selling and services in the amount 9,368 million baht increased 2,170 million baht or 30.1% from the same period of the previous year. Mainly due to revenue type hardware and software increased from the large project with investment in sever and hardware computers and software as Thai economic had been recovery in more investment projects. As a result, the company had been the gross profit of 1,203 million baht which increased in the amount of 143 million baht or 13.5%. Gross profit margin was 12.8% which decreased from the same period of the previous year derived from competitive environment increasing in IT industry.

The company had other income in the amount of 83 million baht, which increased in the amount 19 million baht, mostly from actual gain on the exchange rate. Meanwhile, the company had other loss in the amount of 25 million baht from unrealized profit on exchange rate that the company had foreign exchange forward contracts.

The company had selling and administrative expenses were 947 million baht, which increased in the amount of 27 million baht. Mainly from selling expenses increased in the amount of 13 million baht, which corresponds to the increased in revenue and administrative expenses increased in the amount of 15 million baht, Mainly from employee expense.

Moreover, the company had a reversal of Impairment loss determined in accordance with TFRS 9 by 1 million baht which resulted in expense decreased by 41 million baht from the year 2021, which the company had a reversal of Impairment loss from received debt payment from one of the company's debtors.
