The operating results for 2022 mainly derived from the oil tanker fleet transportation service business.

For 2022, the Company generated total revenue from fleet transportation service business for petroleum and chemical products, composed of Baht 726.5 million, Baht 0.7 million, and Baht 2.3 million from the freight charges, gain on exchange rate, and other revenues, respectively.

For 2022, the total freight charges of the Company was Baht 726.5 million, an increase of Baht 63.7 million compared to 2021 or decreased 9.6%.

This was caused by an increased in the domestic and a decreased of international freight charges, this was due to

- The number of voyage of the domestic has increased due to the relaxation some COVID-19 restrictions which affected to the demand for oil consumption in the country has increased.
- The number of voyage of the international decreased due to the decreased of international vessel fleet by the Company has sold one vessel that provides for the international route since 1Q22, namely V.L. 10.


## Cost of freight

For 2022, cost of freight of the Company was Baht 611.2 million, an increase of Baht 60.2 million compared to 2021 or increased 10.9% due to fuel costs are increased from the volatility of fuel prices during 2022 that tends to increased.

**Gross profit** 

For 2022, gross profit of the Company was Baht 115.3 million or gross profit margin of 15.9% of total freight charges, an increase of Baht 3.5 million compared to 2021 or increased 3.1%. This was a result of the total freight charges to increase.

Administrative expenses

For 2022, administrative expenses of the Company was Baht 37.8 million, an increase of Baht 5.2 million compared to 2021 or increased 16.0% due to in 2022 the Company had unrealized loss from foreign currency forward contract amounting to Baht 5.3 million. The Company entered into a foreign currency forward contract with a financial institution which have outstanding balance and must be presented at fair value at the end of the accounting period.

**Finance cost** 


For 2022, finance cost of the Company was Baht 35.3 million, a decrease of Baht 1.8 million compared to 2021 or decreased 4.9% due to during 2022, the Company had repayment the principal of credit lines with a financial institution.

Income tax expenses

For 2022, income tax expenses of the Company was Baht 3.5 million, a decrease of Baht 2.6 million compared to 2021 or decreased 42.6% due to which varied by increased profit under investment promotion.

Income for the year

For 2022, income for the year of the Company was Baht 23.4 million, an increase of Baht 0.5 million compared to 2021 or increased 2.2% due to the increased of the freight charges.

As of 31 December 2022, the Company reported total assets of Baht 1,882.1 million, a decrease of Baht 69.9 million compared to 31 December 2021 or decreased 3.6% due to

- Increase in cash and cash equivalents amounted to Baht 15.8 million because of the Company
  has the operating cash flow increased in 2022.
- Vessels and equipment has decreased in the amount of Baht 75.1 million because of in the 1Q22 the Company sold V.L. 10 and there is depreciation of vessel and equipment contained in the account.

#### Liabilities

As of 31 December 2022, the Company reported total liabilities of Baht 944.3 million, a decrease of Baht 112.8 million compared to 31 December 2021 or decreased 10.7% due to

- The trade and other current payables, and payables of purchase of assets increased in the total amount of Baht 25.8 million because of the Company had a whole increase in services and spare parts payables.
- The other liabilities increased in the amount of Baht 9.3 million because the Company has an
  undue output VAT of Baht 4.0 million and the financial liabilities from the foreign exchange forward
  contract of Baht 5.3 million.
