## Revenues

For the year 2022, the company and subsidiaries reported total revenues of 662.91 million baht, decreased by 135.13 million baht or equivalent to 16.93 percent compared to the same period of previous year. The revenue from sale of real estate was 661.23 million baht, decreased by 134.39 million baht, accounting for 16.89 percent, the decreased revenue from sale of real estate was from sale of townhome/semi-detached house decreased by 51.51 million baht and sale of condominium decreased by 82.88 million baht. The main reason was financial striction of credit approval and some buyers concerned about financial uncertainty in the future, they therefore delay their purchase. Meanwhile, the decrease in sales of condominiums was from a small amount of remaining units.

#### Cost of real estate sold

For the year 2022, cost of real estate sold was 463.77 million baht or accounting for 70.14 percent while cost of sale real estate in the same period of previous year was 553.79 million baht, accounting for 69.60 percent of revenue from sale of real estate, decreased by 90.02 million baht or equivalent to 16.25 percent compared to the same period of previous year. The decrease was the same direction of revenue from sale of real estate.

#### Selling expenses

Selling expenses for the year 2022 was 60.28 million baht or accounting for 9.09 percent of total revenues, decreased from the same period of previous year by 1.14 million baht or equivalent to 1.86 percent.

#### Administrative expenses

Administrative expenses for the year 2022 was 85.09 million baht or accounting for 12.84 percent of total revenues, increased by 3.09 million baht or equivalent to 3.77 percent from the same period of previous year.

## **Financial costs**

Financial costs for the year 2022 was 2.98 million baht or accounting for 0.45 percent of total revenues, increased by 2.59 million baht or accounting for 664.10 percent from the same period of previous year due to financial costs of land and cost project held for development and completed project were unable to record as property development for sale.



# Net profit

Net profit for the year 2022 was 42.40 million baht or accounting for 6.40 percent of total revenues, decreased from the same period of previous year by 37.68 million baht or accounting for 47.05 percent. The decrease was the same direction of revenue from sale of real estate.

## Assets

Total assets decreased from 2,210.61 million baht to 2,149.10 million baht, decreased by 61.50 million baht or equivalent to 2.78 percent.

#### Liabilities

Total liabilities decreased from 1,372.18 million baht to 992.94 million baht, decreased by 334.24 million baht or equivalent to 25.18 percent due to

- Bank overdrafts and short-term loans and from financial institutions decreased by 38.60 million baht or equivalent to 70.99 percent,
- Short-term loans from a related party decreased by 75.00 million baht or equivalent to 30.61 percent,
- Long-term loans from Financial Institutions decreased by 160.96 million baht or equivalent to 27.71 percent.

# Shareholders' equity

Total shareholders' equity increased from 883.43 million baht to 1,156.16 million baht, increased by 272.73 million baht or equivalent to 30.87 percent due to the company entered into an Initial Public Offering through the Market for Alternative Investment (mai) on 7 July 2022 and net profit for the year 2022.
