For the year ended 2022, the Company has a total revenues of 664.05 million baht. The increased revenue come from winning in 2 IOM service projects of BMA's wastewater treatment plants: 1) Nong Khaem

- Thung Khru wastewater treatment plant phase 4 in 2020; and 2) Din Daeng wastewater treatment plant phase 4 in 2021; and winning in 1 IOM service project of BMA's drainage tunnel: Bueng Makkasan-to-Chao Phraya River drainage tunnel phase 3. In addition, the Company has been focusing on expanding in new project to other public entities and private entities in various industries to broaden the customer base and decreased dependency of any specific customers, as well as extending work into EEPI project to complete full services of water system management which increase opportunities to obtain IOM projects subsequently. The Company's revenue in the first nine months of 2022 majorly comes from IOM water management services, accounted for 89.22% of total revenues and revenue from EEPI projects, accounted for 10.71% of total revenues.

The Company's gross profit in the year ended 2022 was 128.62 million baht equivalent to a gross profit margin of 19.38%. The gross profit grew in line with the increasing in total revenues and gross profit margin. The increasing in gross profit margin came from both active projects and newly acquired projects due to changes in the scope of work, especially in the main projects with BMA which had less maintenance activities, together with an efficient operational planning and cost management. Moreover, the Company has developed software technology based on the practical data obtained from actual operations to increase operational efficiency.

The Company's net profit in the in the year ended 2022 was 68.01 million baht, equivalent to net profit margin of 10.24%. The increase in net profit margin is aligned with the higher of gross profit margin, supported by efficient management in administrative expenses.

As of December 31, 2022, the Company had total assets of 806.85 million baht, which increased by THB 256.73 million bath or 46.67% from the same period of the previous year. the Company's total assets increase from cash the Initial Public Offering (IPO) of newly issued shares.

As of December 31, 2022, the Company had total liabilities of 246.17 million baht, which decreased by THB 60.74 million bath or 19.79% from the same period of the previous year. the Company's total liabilities decrease from trade and other payables of new projects

As of December 31, 2022, the total shareholders' equity was 560.68 million baht, which increased by THB 317.47 million bath or 130.53% from the previous year, which is increased from the net profit. In addition, in 2022, increase the new company ordinary shares registered and paid-up capital and also the premium on ordinary shares of the Initial Public Offering (IPO)
