The Company had a net loss of 161.75 million Baht, loss increased by 11.12 million Baht or 7.38% when compared to the same period last year which had a net loss of 150.63 million Baht. However, if the Company excluded the operating results of the associated company, the Company had a net profit of 155.51 million Baht.

The operating result in separate financial statements of the Company for the year ended December 31, 2022, the Company had a net profit of 155.51 million Baht, increased by 303.74 million Baht or 204.91% when compared to the same period last year which had a net loss of 148.23 million Baht. The main factors are because the Company received the interest from loan to the associated company since quarter 3 in year 2022 in a total of 154.60 million Baht. In addition, the Company also received the

repayment from loan and bill of exchange which had been provided allowance for expected credit loss in the year 2021 and a decrease in provision for litigation.
