Gross profit is Revenue deduct cost of goods sold which include raw material, direct labor and overhead. In 2022 our gross profit increase of baht 81.07 million or 84.79 percent. Gross margin from sale and services increases from 25.05 in 2021 to 29.00 in 2022 due to the increase of sales and the down trend of cost of steel and wood which are one of our main materials start from July 2022.

Selling and distribution expenses and Administrative expenses mainly are Employee expense, Rental, Utilities expense, Marketing expense and Depreciation and Amortization expense. In 2022 Selling and Administrative expenses increase from 157.67 million baht in 2021 to 185.06 million baht in 2022 or 17.37 percent but in the point of percentage to sale the Selling and distribution expenses and Administrative to Sale is decrease from 41.31 in 2021 to 30.37 in 2022 due to the increase of sale together with the continuously strictly expenses control policy.
