This transaction is recognized as a transaction more than 0.03% of NTA but not over 3% of NTA which is deemed a medium-sized transaction regarding business supporting transaction with not normal commercial condition according to the regulation. The Management must be approved and disclose to the Stock Exchange of Thailand.
