Super Energy Corporation Public Company Limited ("the Company") would like to inform you of the operating results of the company's consolidated financial statements for the Quarter 1 ending March 31, 2023, with important details as follows.

Key Milestones in Y2022

- On January 20, 2023, the solar power plant with a battery project to distribute electricity 24 hours at Han Sai Subdistrict, Mueang Aranyaprathet District, Sra-Keaw Province of Super Solar Hybrid Co., Ltd. (SSH), a subsidiary of SUPER, supplied commercial electricity to the Electricity Generating Authority of Thailand (EGAT) which has a power purchase agreement (PPA) of 16 MW.
- On April 5, 2023, the Group of Companies was selected according to the regulations of the Energy Regulatory Commission. Regarding the supply of electricity from renewable energy in the form of a Feed-in Tariff (FiT) 2022 2030 for the Group without fuel costs, 2022, including wind power, ground-mounted solar power, and solar power on the ground with the Battery Energy Storage System (BESS), and for industrial waste, totaling 19 projects with a total installed capacity of 361.196 MW, with the details of each type as follows:



Quarter 1/2023 compared to Quarter 1/2022

Gross Profit

The Company has gross profit for the quarter of 1/2023 was 1,465.23 million baht, an increase of 137.05 million baht or 10.32% compared to last year. From the recognition of revenue from 2 new commercial electricity distribution projects, consisting of (1) SPP Hybrid Project in Sa Kaeo Province and (2) Integrated Community Solid Waste Management Project at Nong Khai Province.



Profit for the period

The Company has a profit of 515.40 million baht, a decrease of 37.40 million baht or a decrease of 6.77% compared to the same period last year due to increased financial costs.



Revenue from solar projects in Thailand

The Company has revenue from solar power projects in Thailand in the quarter 1/2023 in the amount of 1,290.78 million baht, an increase of 76.19 million baht or an increase of 6.27%. The main factor is the revenue from the SPP Hybrid project with a capacity of 16 MW that supplied electricity to the commercial system on January 20, 2023, with the revenue of 50.98 million baht in other projects, there was an increase in light intensity compared to the same period last year.

Revenue from solar projects in Vietnam

The Company has revenue from solar power projects in Vietnam in the quarter 1/2023 in the amount of 841.45 million baht, an increase of 16.30 million baht or 1.98% increase due to the increase in light intensity with a total capacity of 836.72 MW.

Revenue from waste thermal power plant

The Company has revenue from waste to energy projects in the quarter 1/2023 in the amount of 270.80 million baht, an increase of 87.92 million baht or an increase of 48.07% due to

- (1) Revenue from the integrated Community Solid Waste Management Project at Nong Khai Province, capacity of 6 MW, was distributed to the commercial system on November 30, 2022, in the amount of 28.14 million baht.
- (2) Reduced maintenance management enabling to produce more electricity increasing the revenue of 29.16 million baht.
- (3) Due to the increase in FT value between January and March 2023, projects with revenue from the Adder system have an increase in revenue of approximately 29.67 million baht.

Revenue from wind power plant

In the quarter 1/2023, the Company has income from wind power plant projects in the amount of 162.68 million baht, an increase of 31.34 million baht or 23.86% increase due to better weather conditions. Cause the average wind speed increased compared to last year.

Other Business (1)

The Company has income from other businesses in the quarter 1/2023 in the amount of 104.04 million baht, an increase of 1.45 million baht or 1.41% increase due to revenue from I-REC in the amount of 4 million baht. Revenue from selling water for consumption decreased from some projects having stopped water delivery due to the improvement of the quality of the wells, which will resume water delivery in April 2023.

(2) Total Cost

The Company has cost of sales and services in the quarter 1/2023 amounted to 1,204.52 million baht, an increase of 76.15 million baht or an increase of 6.75% in line with the increase in revenue and from projects that start commercial electricity from solar power projects and waste-to-energy power projects in Thailand.

(4) Selling and administrative expense

The Company has sales and administrative expenses in the quarter 1/2023 in the amount of 218.53 million baht, an increase of 40.27 million baht or an increase of 22.59% caused by the operating expenses of the Vietnam project is approximately 10.69 million baht and tax on interest payments on loans from subsidiaries in Vietnam approximately 13.58 million baht. In addition, the Group of Companies has recorded an allowance for expected credit losses incurred from debt default for long-term loans to other parties amounting to 4.63 million baht.

(5) Financial costs

The Company has financial costs in the quarter 1/2023 in the amount of 874.41 million baht, an increase of 285.16 million baht or an increase of 48.39%, mainly due to the rise in interest rates on USD loans compared to last year.

Assets

As of March 31, 2023, the Company has total assets of 83,189.32 million baht, a decrease from total assets as of December 31, 2022, in the amount of 662.14 million baht or a decrease of 0.79% with the main reason as follows:

Current Assets

- Cash and cash equivalents decreased by 934.68 million baht or decreased by 44.02% in line with the decrease in trade payables and loans from financial institutions.
- Trade accounts receivable and other current receivables increased by 553.92 million baht or 20.40%
 from trade accounts receivable and accrued income from renewable energy power plant projects.
 Which is the normal accrual period.

Non-current Assets

- The land, plant, and equipment decreased by 490.85 million baht or decreased by 0.83%, some of which were caused by depreciation expenses decreased by approximately 750.25 million baht and decreased from the convert of the exchange rate assets in Vietnam, which dropped from the last year by approximately 206.75 million baht. In this regrad, there were assets in power plant projects in Vietnam and Thailand, an increase of about 252.76 million baht and 127.84 million baht, respectively.
- Other non-current assets increased by 289.41 million baht or 6.82%, mainly from advance payments for purchasing assets of wind power projects in Vietnam under construction.

Liability

As of March 31, 2023, the Company has total liabilities of 61,222.25 million baht, a decrease of 1,129.68 million baht or 1.81% compared to December 31, 2022, due to a decrease in trade accounts payable and repayment of

institutional loans. As a result, as of March 31, 2023, the financial structure has a debt-to-equity ratio of 2.79 times, which is still under the conditions the Company provides to financial institutions.

Shareholders' Equity

As of March 31, 2023, the Company has shareholders' equity of 21,967.07 million baht, an increase from shareholders' equity as of December 31, 2022, in the amount of 467.55 million baht or an increase of 2.17% from the recognition of profit in the quarter 1/2023 increased.

The company is determined to develop the potential of operating in the renewable energy business. To be a leader in the renewable energy business.
