The Group's total sales revenue for three months ended 31 March 2023 was 169.83 Million Baht, which decreased 41.41 Million Baht or 24 percent from the same period last year. The main reason is the impact of the negative social trend information dissemination of dietary supplements. coupled with the current economic recession. As a result of this, therefore the company reduces the dissemination of advertising media brings to the decreased of sale order quantity of this product.

Gross Profit

Gross Profit for three months ended 31 March 2023 was 77.09 Million Bath, It was decreased 40 percent from the same period last year. Because the production cost of the marketed product group has a high cost. In addition, the company has organized a free product promotion in the sale of a set of products to stimulate consumer purchases. As a result, gross profit has decreased.

Selling Expenses

Selling expenses for the three months ended 31 March 2023 were 54.09 Million Baht. It was decreased 35.96 Million Baht or 66 percent from the same period last year, mainly due to the company cut down the advertising and promotion expenses such as television program broadcast time rent, advertising production cost, actor salary and promotion cost. In line with the current market situation.

Administrative Expenses

Administrative expenses for three months ended 31 March 2023 were 23.70 Million Baht. It was Increase 2.78 Million Baht or 12 percent due to increased depreciation and asset disposal losses

Net Profit

As a result of company policy to cut down selling expenses, The Company has net profit for the for three months ended 31 March 2023 was 2.84 Million Baht, It was Increase of 5.06 Million Baht or equals to 178 percent from the same period last year.
