- 1. Total revenues for the three-month ended March 31,2023 was 316.83 million baht, compared to the same period of the previous year was 305.95 million baht, an increase of 10.88 million baht or 3.56%
- 2. Total expenses for the three-month ended March 31,2023 was 251.10 million baht, compared to the same period of the previous year was 245.79 million baht, an increase of 5.31 million baht or 2.16%, this was mainly due to administrative expenses in the amount of 101.82 million baht, an increase of 10.82 million baht or 11.89% due to an increase in the number of employees and employee compensation.
- 3. Expected credit losses for the three-month ended March 31,2023 was 16.00 million baht, compared to the same period of the previous year was 10.73 million baht, an increase of 5.27 million baht or 49.11%
- 4. Loss on impairment and disposals of assets foreclosed for the three-month ended March 31,2023 was 7.85 million baht, compared to the same period of the previous year was 1.37 million baht, an increase of 6.48 million baht or 472.99%
- 5. Financial costs for the three-month ended March 31,2023 was 19.50 million baht, compared to the same period of the previous year was 14.00 million baht, an increase of 5.50 million baht or 39.29% due to rising interest rates.

Total assets: The company had total assets as of March 31,2023 of 2,836.17 million baht, a decrease of 373.71 million baht from the year ended 2022 or 11.64%, the main reason was the remaining bank deposits from the IPO capital increase are used to repay loans from financial institutions by allocation of the utilization of capital increase within the original objectives.

2. **Total liabilities**: The company had total liabilities as of March 31,2023 of 1,706.94 million baht, a decrease of 391.59 million baht from the year ended 2022 or 18.66%, mainly due to a decrease in loans from financial institutions.

3. Shareholders' Equity: The Company had shareholders' equity as of March 31,2023 of 1,129.23 million baht, an increase of 17.88 million baht from the year ended 2022 or 1.61%, mainly due to an increase in profit for the period.
