The Company would like to clarify the cause of change as follows:

1. Revenue

For Q2/2023 the Company reported revenue from sale amount THB 93.70 million or decrease THB

175.44 million compare to the previous year's sale amount THB 269.14 million due to the price

competitive situation. Domestic Sale amount THB 68.59 million or decrease THB 35.51 million and

Export Sale amount THB 25.11 million or decrease THB 139.93 million.

2. Other Revenue

Other revenue for Q2/2023 (exclude exchange rate) amount THB 3.25 million increased from the

same previous year by THB 0.45 million mainly due to revenue from rental increased THB 0.31 million

and interest earn increased THB 0.14 million.

3. Gross Profit

For Q2/2023, the Company reported Loss on Gross Profit at THB 21.35 million, compare to the

previous year that the company reported on Gross profit THB 2.96 million, Loss from the same

previous year by THB 24.31 million due to lower on sale revenue in this quarter.

4. Distribution Costs and Administrative Expense

For the Q2/2023, Distribution Costs and Administrative Expense was THB 77.09 million increased

by THB 4.05 million or 5.5 % mainly due to the increase of expense from employee expense and the

other cost had increased from operation.

5. Financial Costs

For the Q2/2023 Financial Costs was THB 2.98 million increased by THB 1.45 million due to increase

in short term loan from related company amount THB 1.98 million.
