Gross Profit

Gross profit is Revenue deduct of cost of goods sold which include raw material, direct labor and overhead. In Second quarter of the year 2023 our gross profit increase of baht 13.28 million or 38.60 percent. Gross margin from sales and services increases from 27.43% in the second quarter of the year 2022 to 34.52% in this quarter due to the increase of sales and production which made a lower unit cost and create a better gross profit and margin.

Selling and Administrative Expenses

Selling and Administrative expenses mainly are Delivery and Installation Cost, Employee expense, Rental, Utilities expense, Marketing expense and Depreciation and Amortization expense. In the second quarter of the year 2023 Selling expenses increase from 20.85 million baht in the second quarter of the year 2022 to 24.84 million baht in this quarter due to the increase of sales. Administrative expenses increase from 22.34 million baht in the second quarter of the year 2022 to 23.99 million baht in this quarter. However, if look at the percentage of Revenue, the percentage of administrative expenses decrease from 17.82% in the second quarter of 2022 to 17.37% in this quarter. mainly due to continuously maintaining a strict expenses control policy.
