Executive Summary Quarter 2/2023 Performance

Wattana Karnpaet Public Company Limited ("Company") reported the total income in Quarter 2 of 2023 to be Baht 116.527 million, decreased from Baht 125.804 million in Quarter 2 of 2022, or decreased by 7.37%. The decrease in income was mainly due to the decrease in the Covid-19 patients in 2023.

In Quarter 2/2023, the Company has EBITDA of Baht 24.96 million, which decreased from Baht 35.142 million.

From the above mentioned, the Company reported net profit of Baht 11.478 million, the net profit decreased by 45.38% from the same quarter last year.
