Begistics Public Company Limited (the "Company") would like to submit the financial statements for the three-month period ended June 30, 2023, with the Company's operating results compared to the same period last year, along with I would like to summarize the key points of the operating results as follows:

Revenue

The Company has total assets as of 30 June 2023 in the amount of 7,586.19 million baht, an increase from the end of 31 December 2022 in the amount of 5,172.69 million baht, representing a rate of 214.32 percent, because Begistics Public Company Limited has cash and cash equivalents. 623.47 million baht and for the part of The Megawatt Company Limited ("Megawatt") from the existing shareholders in the amount of 4,960,000 shares, in which the Company holds 70.16 percent of Megawatt, resulting in MW became a subsidiary of the Company There were short-term loans and accrued interest to related parties of 455.20 million baht in current assets. As for non-current assets, property, plant and equipment – net 1,744.23 million baht and goodwill 1,537.88 million baht of The Megawatt Co., Ltd.

Cost

The Company has service costs for the three-month period ended June 30, 2023 in the amount of 121.77 million baht, a decrease from the same period last year in the amount of 30.46 million baht, representing 20.01% from the previous year. Administrative expenses decreased by 3.31 million baht, representing 8.01% due to the decline in service revenue.



Net profit

For the three-month period Ended June 30, 2023, the company has a profit from profit sharing from associated companies, namely The Megawatt Company Limited and CPS Shipping and Logistics Company Limited, totaling 22.41 million baht, which is a decrease from the quarter. in the same period last year in the amount of 1.85 million baht for the three-month period. Ended June 30, 2023, the company had profit for the period in the amount of 102.49 million baht, an increase from the same quarter last year in the amount of 75.71 million baht, representing a rate of 282.74%

Asset

The Company has total assets as of 30 June 2023 in the amount of 7,586.19 million baht, an increase from the end of 31 December 2022 in the amount of 5,172.69 million baht or 214.32 percent due to the sale of 20,761,555,194 ordinary shares ("RO") and the company Purchased 4,960,000 shares of The Megawatt Co., Ltd. ("Megawatt") from 3 existing shareholders, in which the Company held 70.16% of MW. became a subsidiary of the Company.

Debt

The Company has total liabilities as of 30 June 2023 in the amount of 3,285.83 million baht, an increase from the end of 31 December 2022 in the amount of 3,039.88 million baht or 1,236%, most of which are long-term loans from financial institutions of The Megawatt Co., in the amount of 1,764.89 million baht.

Equity

The Company sold 20,761,555,194 ordinary shares ("RO"), resulting in the Company's shareholders' equity in the second quarter ended June 30, 2023 in the amount of 4,300.36 million baht, an increase of 2,132.81 million baht, representing a percentage 98.40 from the end of December 31, 2022
