The Board of Directors Meeting of Globlex Holding Management Plc. No. 4/2023, held on August 15, 2023, has approved the financial statements reviewed by the auditor of the Company and a subsidiaries for Q2 and 6M ended June 30, 2023. In Q2/2023 Globlex Holding Management Plc. and subsidiaries net loss was Baht 3.67 million, decrease of Baht 12.57 million or -141.26% comparing with net profit Baht 8.90 million for the same period of last year. As for 6M/2023, the net profit was Baht 19.28 million, an decrease of Baht 18.24 million or -48.62% comparing with Baht 37.52 million net profit for the same period of last year.

The Company would like to clarify the reason that the operating results for Q2/2023 and 6M/2023 have changed comparing with the same period of last year as the following;

- 1. Securities brokerage commissions from a subsidiary for Q2/2023 amount Baht 35.71 million, an decrease of Baht 40.25 million or -52.99%. The derivative commissions from a subsidiary amount Baht 6.98 million, a increase of Baht 0.37 million or +5.56%. As for 6M/2023, securities brokerage commissions amount Baht 94.41 million, an decrease of Baht 77.62 million or -45.12%. The derivative commissions from a subsidiary amount Baht 17.14 million, a increase of Baht 2.99 million or +21.15% from the decrease of trading securities volume.
- 2. Fee and services income from securities from subsidiaries for Q2/2023 amount Baht 35.45 million, an decrease of Baht 35.18 million or -49.81%. As for 6M/2023, fee and services income amount Baht 80.39 million, an decrease of Baht 67.67 million or -45.71%, from decreased income of fixed income products underwrite and arrangement and financial advisor fees.
- 3. Gain and loss from securities and derivative trading from the Company and a subsidiary for Q2/2023 a profit amount Baht 5.74 million, an increase of Baht 20.03 million or \pm 140.21%. As for 6M/2023, profit from securities and derivative trading amount Baht 20.31 million, an increase of Baht 30.28 million or \pm 303.75%.
- 4. Interest income the Company and a subsidiary for Q2/2023 amount Baht 24.30 million, an increase of Baht 7.79 million or $\pm 47.16\%$. As for 6M/2023 amount Baht 42.83 million, an increase of Baht 10.35 million or $\pm 31.88\%$
- 5. The total operating and administrative expenses for Q2/2023 amount Baht 119.27 million, an decrease of Baht 30.17 million or -20.19%. As for 6M/2023 amount Baht 239.61 million, an decrease of Baht 78.03 million or -24.57% from decreased of employee benefit expenses and fees and services, as a result of decreased revenue from securities business.
- $6.\ \text{Tax}$ expenses from a subsidiary for 6M/2023 Baht 6.10 million, an decrease Baht 4.61 million or -43.04% from the decrease of net profit.

Progress of loan and loan repayment

Loan to other persons and other company during the Q2/2023, Loan to other company non-related party to Botan Blanket Co.,Ltd. amount Baht 300 million. It is a short-term loan for a period of 6 months with loan guarantor and asset as collateral. On August 2, 2023 the Company has already received repayment the loan for the amount of Baht 100 million.
