**Revenues** For quarter 2/2023, the company and subsidiary's total revenue was Baht 179.60 million, decreased by Baht 40.81 million or equivalent to 18.52%, compared with the same period of the previous year. The primary cause is the decreasing revenues from transportation service and chemical tradings the major revenues comprise of:

For quarter 2/2023, the company and subsidiary's revenues from transportation service, assets rental, driver behavior monitoring service, hire-purchase interest and chemical tradings were Baht 172.84 million, comprise of:

- Revenues from transportation service, which is the company's major income were Baht 146.39 million or 81.51 % of total revenue, decreasing from the same period of the previous year by Baht 25.46 million or equivalent to 14.82% resulting from some contracts expired.
- Revenues from other service as revenues from assets rental, driver behavior monitoring services and hire-purchase interest were Baht 18.51 million, equivalent to 10.31% of total revenue, increasing from the same period of the previous year by Baht 4.80 million or equivalent to 35.03% resulting from contracts renewals from existing customers.
- Revenues from sales were Baht 7.94 million, equivalent to 4.42% of total revenue, decreasing from the previous year by Baht 20.28 million or decreased by 71.88% resulting from customers' slowing down consumption and orders.

<u>Total cost</u> For quarter 2/2023, the company and subsidiary's total cost was Baht 118.15 million or equivalent to 65.78 % of total revenue, decreasing from the same period of the previous year by Baht 29.67 million or decreasing by 20.07 %, which is in line with the decreased in revenues.

**Gross profit** For Q2/2023, the company and subsidiary's gross profit were Baht 54.69 million in total, or equivalent to 30.45% of total revenue, decreasing from the same period of the previous year by Baht 11.28 million or decreasing equivalent to 17.10% owing to the company's and its subsidiary's decreasing revenue.

<u>Selling and Administrative expenses</u> The Company and subsidiary's selling and administrative expenses for quarter 2/2023 were Baht 36.71 million, increasing from the previous year by Baht 0.14 million or increasing equivalent to 0.38%.

<u>Interests & Income Tax expenses</u> The Company and subsidiary's interests and corporate income tax expenses for quarter 2/2023 were Baht 5.68 million or equivalent to 3.16% of total revenue.

**Net profit** The Company and its subsidiary's net profit for quarter 2/2023 were Baht 19.07 million or equivalent to 10.62% of total revenue, which decreased from the same period of the previous year by Baht 9.13 million or decreasing equivalent to 32.39%, resulting from the economic slowdown, customers' decreased order and consumption, and expired contracts.
