According to the Notification of the Capital Market Supervisory Board No. TorJor.20/2551 Re: Rules on Entering into Material Transactions Deemed as Acquisition or Disposition of Assets (as amended) and Notification of the Board of Governors of the Stock Exchange of Thailand Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition or Disposition or Disposition of Assets B.E. 2547 (as amended) (collectively referred to as "Acquisition or Disposition Notifications"). The maximum transaction size is 0.68% based on the total value of consideration, which is the maximum transaction size calculated from the financial statements of the Company that has been reviewed by the audited by auditor as of June 30, 2023. The transaction size is considered an asset acquisition transaction with the transaction size less than 15% and the Company has no other asset acquisition transactions that occurred during the past 6 months prior to the date of entering into the transaction. Therefore, it is not considered a transaction that requires disclosure under the Acquisition or Disposition Notifications.

Nonetheless, the Company still has a duty to disclosure information according to the Regulation of the Stock Exchange of Thailand Re: Rules, Conditions, and Procedures Governing the Disclosure of Information and Other Acts of a Listed Company B.E. 2560 (Bor.Jor./Por. 11-00).
