Revenue

Contracted Revenue

In 2Q2023, Contracted Revenue (excluding other revenue) was 882.3 million baht, increasing by 140.6% from 336.7 million baht in 2Q2022. The Contract Revenue increased from the actual progress recognition from CRISP and SANTOS as compared to the same period of last year, especially for CRISP Project will remain in revenue recognition until the end of 2023.

Other Revenue

In 2Q2023, other revenue (excluding FX gain) was 16.9 million baht, increasing by 148.5% from that in 2Q2022 at 6.8 million baht due to the increasing in interest and dividend income.

Expenses

Contracted Costs

Contracted Costs in 2Q2023 was 851.8 million baht, rising by 142.1% as compared to that in 2Q2022 at 351.8 million. The increase in Contracted Costs was in line with rising project activities.

Selling, General and Administrative expenses (SG&A)

Selling, General and Administrative expenses (SG&A) in 2Q2023 was 45.7 million baht, increasing by 3.1% from 2Q2022 which was 44.3 million baht due to rising project activities.

Foreign Exchange (FX) Impact

In 2Q2023, the Company recognized FX gain by 65.5 million baht as compared to FX gain in 2Q2022 at 56.9 million baht.

Gross Profit and Net Profit

In 2Q2023, Gross Profit was at 30.5 million baht, increasing by 104.7% from 14.9 million baht in 2Q2022. On the other hand, Net profit in 2Q2023 was at 57.5 million baht, increasing by 82.5% from 31.5 million baht in 2Q2022 due to reasons as explained above.
