ASN Broker Public Company Limited ("the Company" or "ASN") would like to inform you of our consolidated operating results for Q2/2023 period ended June 30, 2023, as follows:

Analysis of operating results

Revenues

ASN Group recorded total revenues of THB 79.31 million in the first six months of 2023 ("6M/2023"), increasing by 7% from THB 74.27 million in the first six months of 2022 ("6M/2022"). The revenues, classified by core business lines, are as follows:

1. Insurance broker business

- Non-life insurance broker

ASN Group recorded income from non-life insurance broker business of THB 38.39 million in 6M/2023, dropping by 10% from THB 42.45 million in the same period of 2022 mainly due to a decrease in number of telemarketing staffs. The Company is currently planning on additional staff recruitment to meet the workforce target.

- Life insurance broker

Income from life insurance broker business in 6M/2023 accounted for THB 1.07 million, plummeting by 33% from THB 1.59 million in 6M/2022. This resulted chiefly from the cessation of sales of first-year life insurance since Q3/2019 due to a drop in yields on competitive products.

2. Lending business

- Investment in peer to peer lending platform

From the investment in the peer to peer lending business through Daingern.com platform, ASN Group generated interest income of THB 0.09 million in 6M/2023, plunging by 92% from THB 1.15 million in 6M/2022 due primarily to the Company having ceased its investment in the Daingern.com platform service since August 2019. After the issuance of the Bank of Thailand's Notification Re: Determination of Rules, Procedures, and Conditions for Electronic System or Network for Operation of the Peer-to-Peer Lending Business, the Company has since been unable to make the investment through Daingern.com platform.

- Personal loan

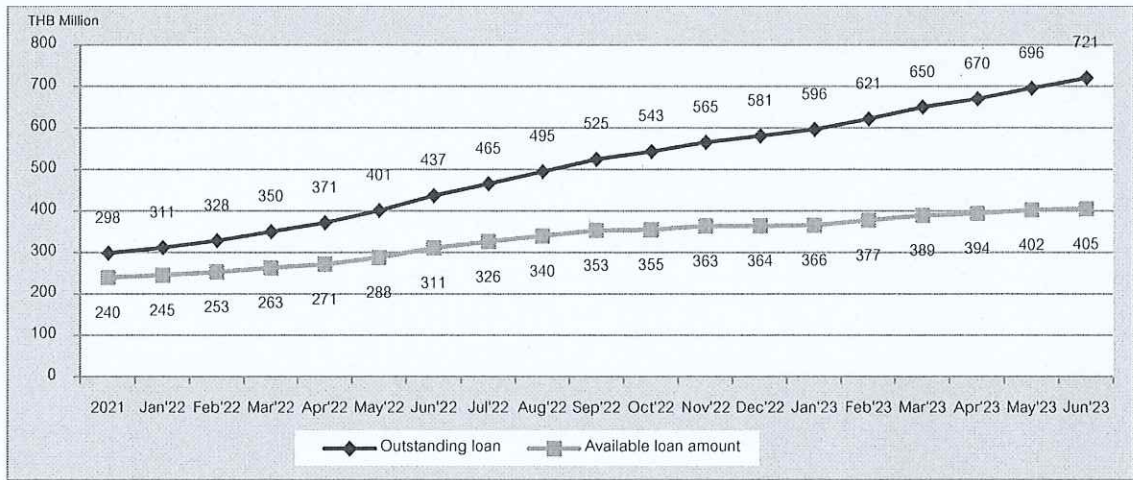


Figure 1: Growth in ASN Finance Business

ASN Group recorded interest income of THB 34.49 million in 6M/2023, a surge 45% from THB 23.83 million in 6M/2022 thanks to growth in the personal loan business as illustrated in Figure 1: Growth in ASN Finance Business.

As at June 30, 2023, the outstanding loan totaled THB 720.67 million and the available loan amount was THB 404.99 million, with NPL standing at 1.53%.

On May 8, 2023, the Company opened the first branch, Bang Yai Branch, as an additional channel to serve customers.

3. Peer to peer lending platform service business

ASN Group provides the peer to peer lending platform service through Daingern Dotcom Co., Ltd. on Daingern.com platform. Revenues from this service were THB 1.93 million in 6M/2023, shrinking by 21% from THB 2.44 million in 6M/2022, which mainly resulted from the following factors:

- The Company has ceased the P2P service on Daingern.com platform since January 27, 2020 to gear up for participation in testing of the electronic system or network service provision in the Bank of Thailand's regulatory sandbox, thereby causing a decrease in service income in the amount of THB 1.48 million.
- The Company commenced the testing of such service provision in the regulatory sandbox on March 1, 2022, leading total service income to increase by THB 1.06 million.

- Other revenues

Other revenues totaled THB 3.34 million in 6M/2023, rising by 19% from THB 2.82 million in 6M/2022, which was chiefly attributed to bad debts recovered and income from policy cancellation fees.

Cost and expenses

- Cost and expenses of services amounted to THB 29.60 million in 6M/2023, going down by 4.9% from THB 31.13 million in 6M/2022 which resulted mainly from a decrease in number of employees in the non-life insurance broker business.

- Administrative expenses totaled THB 39.92 million in 6M/2023, which rose by 10.0% from THB 36.28 million in 6M/2022 due to employee-related expenses and marketing expenses in the personal loan business and the peer to peer lending platform service.

- Finance cost amounted to THB 6.06 million in 6M/2023, a decrease of 1.9% from THB 6.18 million in 6M/2022 resulting chiefly from interest expenses under lease agreements from recognition of the item in accordance with TAS16 Property, Plant and Equipment.

- Expected credit losses accounted for THB 1.11 million in 6M/2023, jumping by 126.9% from reversal of ECL of THB 4.13 million in 6M/2022. This was ascribed partly to accounts receivable in the personal loan business and partly to adjustment to reversal of expected credit loss item in 2022.

However, reversal of ECL in Q2/2023 was THB 0.41 million, plunging by 120% from THB 2.03 million in Q2/2022 due to improvement in management of accounts receivable in the personal loan business.

Profit

- ASN group posted a gross profit of THB 46.37 million in 6M/2023, with a gross profit margin of 61.0%.

- Operating profit soared by 42.7% from THB 6.86 million in 6M/2022 to THB 9.79 million in 6M/2023 thanks to healthy growth in revenues.

- The Group reported a net profit of THB 0.58 million in 6M/2023, plummeting by 85.8% from THB 4.09 million in 6M/2022. This stemmed from adjustment to reversal of expected credit loss item in 2022 following the improvement of more suitable assumptions for calculation of such item.

However, a net loss was recorded at THB 0.10 million in Q2/2023, plunging by 93.9% from THB 1.64 million in Q2/2022 due to growth in revenues and a decrease in credit losses on account of improvement in accounts receivable management.

Analysis of the statement of financial position

Assets: ASN Group recorded total assets as at June 30, 2023 of THB 552.50 million, which diminished from 2022 by THB 16.32 million or 16.3%. This resulted mainly from a decrease in cash and cash equivalents of THB 45.65 million, a decrease in investment in peer to peer lending platform of THB 3.11 million, a decrease in accrued brokerage income and other receivables of THB 7.41 million, and a decrease in loans receivable from personal loans under supervision of THB 2.97 million, with an increase in receivables under hire purchase agreements of THB 44.36 million.

Liabilities: The Group recorded total liabilities as at June 30, 2023 of THB 260.07 million, dropping from 2022 by THB 11.90 million or 4.4%. This stemmed from a decrease in insurance premium payables and other payables of THB 11.01 million and a decrease in lease liabilities under TAS16 Property, Plant and Equipment of THB 1.04 million.

Shareholders' equity: The Group had total shareholders' equity as at June 30, 2023 of THB 292.43 million, decreasing by THB 4.42 million or 1.5% due to dividend payment made on April 25, 2023 in the amount of THB 5.0 million and a net profit earned in 2023 of THB 0.58 million.
