According to The Board of Directors of Ratchaphruek Hospital Public Company Limited ("the company") meeting No.3/2023 dated August 5, 2023 the meeting approved the Company's Interim Financial Information ended June 30, 2023. The Company would like to clarify the six-month ended June 30, 2023 operating results, as follows.

Executive Summary

In 2Q2023 the company has recently achieved the Global Healthcare Accreditation with Excellence designation by the U.S. based Global Healthcare Accreditation (GHA) Program. This is a hospital has achieved this honor.

For the six-month period ended June 30, 2023 ("6M2023"), the revenue from hospital operations amounted to THB 549.46 million, decrease of 31.7% from 6M2022. Caused by 1O2022 to 2Q2022 the Company receiving cases of Covid-19 infection patients, opening cohort wards, opening several of Hospitel treatments and opening of Home Isolation treatments. However, in 2Q2023, the situation of the epidemic of COVID-19 was unfolding cause to the lower Covid-19 patients. Although, a return of non Covid-19 patients in 6M2023 increased from 6M2022 but it's still lower than the decrease of receiving case of Covid-19 infection patients which caused by 2Q2023 performance is decreased significantly.

The six-month period ended June 30, 2023 ("6M2023"), the Company reported EBITDA of THB 151.95 million, decreased of 56.2% from 6M2022 due to changes in revenue structure which led to an absence of massive Covid-19 related revenue.

Revenue from hospital operations

For the six-month period ended June 30, 2023 ("6M2023"), the revenue from hospital operations amounted to THB 549.46 million, decrease of 31.7% from 6M2022. Caused by 2Q2022 the Company receiving cases of Covid-19 infection patients. However, in 2Q2023 the situation of the epidemic of Covid-19 was unfolding cause to the lower Covid-19 patients. Although, a return of non Covid-19 patients in 6M2023 increased from 6M2022 but it's still lower than the decrease of receiving case of Covid-19 infection patients which caused by 2Q2023 performance is decreased significantly

However, the performance of 2Q2023 for non Covid-19 revenue has growth rate of 35.34% from 2Q2022.

Cost of hospital operations

For the six-month period ended June 30, 2023 ("6M2023"), the cost of hospital operations amounted to THB 362.78 million, decrease of 15.6% from 6M2022. The cost of hospital operations to revenue ratios for 6M2023 and 6M2022 at 65.09% and 53.14%, respectively. Caused by cost of medicines and medical supplies, the FT value is an adjustment of the electricity was increasing, the depreciation and higher staff expenses. Although, cost of treating Covid-19 patients were lower than non Covid-19 patients.

Distributions costs

For the six-month period ended June 30, 2023 ("6M2023"), the company's distributions costs amounted to THB 9.12 million, increase of 283.2% from 6M2022. The distributions costs to revenue ratios for 6M2023 and 6M2022 at 1.64% and 0.29%, respectively. The higher in ratio on a period-onperiod basis was the company's produced advertising and public relations media in various social media channels.

Net profits

For the six-month period ended June 30, 2023 ("6M2023"), the net profits amounted to THB 81.88 million, decrease of 65.7% from 6M2022 caused by the lower receiving cases of Covid-19 infection patients. Although, a return of non Covid-19 patients in 6M2023 increased from 6M2022 but it's still lower than the decrease of receiving case of Covid-19 infection patients.

Total assets as of June 30, 2023 were THB 1,903.12 million, decrease of 5.3% from December 31, 2022 due mainly to a decrease in cash and cash equivalents, and trade and other receivables.

In addition, the Company's property, plant and equipment as of June 30, 2023 values are THB 1,390.06 million, decrease slightly of 2.6% from December 31,2022 due to the depreciation on a regular basis.

Total liabilities as of June 30, 2023 were THB 180.20 million, decrease of 37.0%. from December 31, 2022 due to the company repaid the full amount of long-term loan from financial institutions in 1Q2023 and payment of trade and account payables and other payables as normal business.

As of June 30, 2023, the shareholders' equities values are THB 1,722.92 million, increase slightly from December 31, 2022.
