Executive Summary

In the year ended the sixth month as of 30 June 2023, the Company had total revenue of Baht 269.35 million, decrease of 34.37% YOY. The total cost of sales and services amounts to Baht 210.97 million, decrease of 55.04% YOY. Resulting in a higher gross profit amount of Baht 58.38 million, a growth of 21.67% YOY. Distribution costs and administrative expenses amounted to Baht 45.73 million, a increase of 2.46% YOY. Net loss for the sixth month period amount of Baht 9.71 million, (3.60%) increased from the same period with previous year number of Baht 17.01 million, 233.01% YOY, other comprehensive income amount to Baht 1.07 million, total other comprehensive income amount to Baht 10.78 million, increase from the same period with last year number of Baht 18.08 million, 247.67% and EBITDA in the second quarter of 2023 number of Baht 19.35 million.

The Company's major reasons for the performance for the second quarter of 2023, the Net loss was impacted by the sales-price competition, including mainly impact from raw material costs such steel prices are lower than previous period, the price also rising oil prices, hence cost of production and cost of goods sold were decreased also labor cost.

Total revenues

The period the sixth month ended on June 30, 2023, the Company had a total revenue amount of Baht 269.35 million, 34.37%, consisting of revenue from sales amount of Baht 194.19 million, which increased 14.42%, consideration with Q'2/2022 revenue from the sale, it's decreased from the previous year, but revenue from construction amount of Baht 72.19 million, decreased 45.18%, revenue from service amount of Baht 0.97 million, decreased 17.80% and other revenue amounts of Baht 2.00 million, 73.91%

The period three month ended on June 30,2023, the Company had a total revenue amount of Baht 133.61 million, decreased 1.58% from prior period, consisting of revenue from sales amount of Baht 96.55 million, decreased 1.12%, construction revenue amount of Baht 36.07 million, decreased 0.14%. Service revenue amount of Baht 0.52 million, increased 15.56%, other revenue amount of Baht 0.47 million, decreased 69.48%

Cost of sales and services

The period the sixth month ended on June 30, 2023, the Company had the total Cost of sales and services amount of Baht 210.97 million, 78.33%, an decreasing amount of Baht 55.04 million, an decrease of 20.69% YoY, Cost of sales and services amount of Baht 143.86 million, 74.08%, there is Cost of construction increased by the amount of Baht 67.11 million, 92.96% YoY of total revenue. Mainly decreased were impacted by the less in the cost of the main raw material (steel). Construction cost is decreased as a result of construction in progress and new project were not start yet.

The period of three months from April 1, 2023, to June 30, 2023, the Company had the total Cost of sales and services amount of Baht 104.71 million, 78.37%, a decreasing from last period amount of Baht 1.55 million, 1.46%, Cost of sales and services the amount of Baht 70.06 million, 72.56%, there is the Cost of Construction amount of Baht 34.65 million, 96.06%.

Distribution costs and administrative expenses

The period the sixth month ended on June 30, 2023, the Company had a total distribution costs and administrative expenses amount of Baht 45.75 million, with 16.98%YoY of total revenue, increased by an amount of Baht 1.10 million, 2.46% from Administrative depreciation. Distribution costs were decreased, there were mainly impacted by Oil and Gas transportation expenses but administration expenses decreased, mainly decreasing from employee's bonus payments, salary payments also with professional fees, and bank fees.

The period the three months from April 1, 2023, to June 30, 2023, the Company had a total distribution costs and administrative expenses amount of Baht 21.63 million, with 16.19% with amount of Baht 2.48 million, 10.29%, mainly decreased from car maintenance, miscellaneous expenses and oil and gas expenses.

Gross Profit and Net Profit

The period the sixth month ended on June 30, 2023, the Company's gross profit amount of Baht 58.38 million, net profit after corporate income tax for the period amount of Baht 9.71 million, other comprehensive income for the period is 10.78 baht of million. Earning per share was the number of baht 0.0211 EBITDA was the amount of Baht 19.35 million. Unappropriated retained earnings amount of Baht 69.24 million.

The period the three months from April 1, 2023, to June 30, 2023, the Company's gross profit amount of Baht 28.90 million, net profit after corporate income tax for the period amount of Baht 5.91 million, and Earned per share was the number of Baht 0.0128 EBITDA was the amount of Baht 10.57 million.
