Financial performance summary of quarter 2/2023 compared to quarter 1/2023

For Q2/2023, the service revenue amounted to Baht 631.22 million, increased by Baht 45.22 million Baht or 7.72% from last quarter. This is mainly from the revenue growth from new projects in Q2/2023 and the revenue from on-going projects of Q2/2023 which is from both Strategy and Technology Consulting and License and Subscription.

For Q2/2023 the net profit amounted Baht 73.04 million whereas the net profit for the equity holder of the company amounted Baht 71.97 million, increasing Baht 10.73 million or 17.52% QoQ. Net profit margin was 11.47% which is slightly increased from the last guarter from the revenue from BE8 products and from the improvement in efficiency operation.

Financial performance summary of 6M/2023 compared to 6M/2022

For 6M/2023, the service revenue amounted to Baht 1,217.22 million, increased by Baht 958.51 million Baht or 370.50% YoY. This is mainly from the revenue recognition of new subsidiaries which are Bay Computing Co., Ltd., Vanilla and Friends Co., Ltd., and Reconix Co., Ltd. together with the revenue growth from Strategy and Technology Consulting and License and Subscription.

For 6M/2023 the net profit amounted to 134.67 million Baht whereas the net profit for the equity holder of the company amounted Baht 133.21 million, increasing 79.41 million Baht or 59.61% compared to the same period of last year. Net profit margin was 10.92% which was decreased from the lower net profit margin of the subsidiaries of the Group. However, the Group is in process to work together to synergize the whole group to increase efficiency and improve the net profit margin for the Group in a period of a few years.
