For the Second Quarter of 2023, the company and subsidiaries reported total revenues of 167.82 million baht, increased by 17.02 million baht or an Increase of 11.29 percent compared to the same period of previous year.

For the 6 month period of the year 2023, the company and subsidiaries reported total revenues of 274.87 million baht, decreased by 50.09 million baht or a decreased of 15.41 percent compared to the same period of previous year.

Cost of sale and services

For the Second Quarter of 2023, cost of sale and services was 108.28 million baht or accounting for 64.54 percent of revenue from sales and services while cost of sales and services in the same period of previous year was 107.10 million baht, accounting for 71.16 percent of revenue from sales and services

For the 6 month period of the year 2023, cost of sale and services was 176.52 million baht or accounting for 64.27 percent of revenue from sales and services while cost of sales and services in the same period of previous year was 227.44 million baht, accounting for 70.26 percent of revenue from sales and services

Selling expenses

Selling expenses for the Second Quarter of 2023 was 17.91 million baht or accounting for 10.67 percent of total revenues, increased from the same period of previous year by 2.69 million baht or increased to 17.67 percent, due to the increased in revenue from sales and services

For the 6 month period of the year 2023, Selling expenses was 30.00 million baht or accounting for 10.91 percent of total revenues, decreased from the same period of previous year by 0.28 million baht or decreased to 0.92 percent.

Administrative expenses

Administrative expenses for the Second Quarter of 2023 was 21.33 million baht or accounting for 12.71 percent of total revenues, increased by 1.12 million baht or increased to 5.54 percent from the same period of previous year.

Administrative expenses for the 6 month period of the year 2023 was 41.69 million baht or accounting for 15.17 percent of total revenues, increased by 0.12 million baht or increased to 0.29 percent from the same period of previous year.

Financial costs

Financial costs for the Second Quarter of 2023 was 0.60 million baht or accounting for 0.36 percent of total revenues, decreased by 0.39 million baht or decreased to 39.39 percent from the same period of previous year.

Financial costs for the 6 month period of the year 2023 was 0.95 million baht or accounting for 0.35 percent of total revenues, decreased by 0.54 million baht or decreased to 36.24 percent from the same period of previous year.

Income Tax

Income Tax for the Second Quarter of 2023 was 4.74 million baht or accounting for 2.83 percent of total revenues, increased by 3.26 million baht or accounting for 220.27 percent from the same period of previous year. due to increased profit.

Income Tax for the 6 month period of the year 2023 was 5.80 million baht or accounting for 2.11 percent of total revenues, increased by 0.88 million baht or increased to 17.89 percent from the same period of previous year.

Net profit

Net profit for the Second Quarter of 2023 was 14.96 million baht or accounting for 8.91 percent of total revenues, increased from the same period of previous year by 9.16 million baht or increased to 157.93 percent. due to higher gross profit margins

Net profit for the 6 month period of the year 2023 was 19.91 million baht or accounting for 7.24 percent of total revenues, increased from the same period of previous year by 0.65 million baht or increased to 3.37 percent.
