According to the Board of Directors meeting no.14/2023 of Thai Coconut public company limited ("Company") on 29th September 2023, the meeting has approved the investment in the project of maximizing production capacity of coconut water packed with UHT PRISMA machine. The investment value is approximately 384.70 million Baht to support the rising demand of coconut water products from customers. After investing, the maximum production capacity will increase from 218,000 tons per year to 310,000 tons per year.

The investment to maximize production capacity of coconut water packed with UHT PRISMA machine is considered as the asset acquisition based on the announcement of the Capital Market Supervisory Board Tor Jor no.20/2008: the principles in conducting a significant transaction, which is the acquisition or disposal of assets. Including, the amended announcement, and the announcement of the committee of Stock Exchange of Thailand: the disclosure of information and actions of publicly listed company in acquiring or disposing of assets in 2004 ("the announcement of acquiring or disposing"). 3. General characteristics of the transaction

The company's investment purpose is to maximize the production capacity of coconut water packed with UHT PRISMA, which is an investment valued at 384.70 million Baht.

4. Type and size of the transaction:

The investment to maximize production capacity of coconut water packed with UHT PRISMA machine is considered as the asset acquisition based on the announcement of Capital Market Supervisory Board Tor Jor no.20/2008: the principles in making a significant transaction, which is the acquisition or disposal of assets. Including, the amended announcement, and the announcement of the committee of Stock Exchange of Thailand: the disclosure of information and actions of publicly listed company in acquiring or disposing of assets in 2004 ("the announcement of acquiring or disposing"). The size of this investment is 11.09 percent, which is the transaction size calculated according to the total value compensation criteria and based on the financial statements of the company ended on 30th June 2023. The details of calculating the transaction size are follow:

Therefore, the aforementioned transaction will have the maximum transaction size at 11.09%, which is lower than 15% based on the announcement of disposing.

5. The details of the asset acquisition

The project of maximizing the production capacity of coconut water packed with UHT PRISMA

machine will have investment in the Aseptic Filing sized 330 ml. for 4 machines, the Aseptic Filing

sized 1,000 ml. for 2 machines, and other related equipment. This investment will cause the rising

production capacity of coconut water for the company, which increase from 218,000 tons per year to

310,000 tons per year. The company expects that this investment can earn commercial revenue in

the first quarter of 2024.

6. Total value of transaction/asset acquisition

The value of the asset acquisition for investment in project of maximizing the production capacity of

coconut water packed with UHT PRISMA machine has the investment value of around 384.70 million

Baht.

7. The criterion of determining investment valuation

This investment was evaluated by the price comparison of management team based on the

company's purchasing procedures in terms of assessing the value of the machines and equipment,

which relate to maximizing the production capacity of coconut water packed with UHT PRISMA

machine. The company will buy all assets with cash. The company has considered the future

benefits which will support the growth of manufacturing business and selling coconut products

continuously.

8. The expected benefits

The investment in the project of maximizing production capacity of coconut water packed with UHT

PRISMA will cause the rising production capacity of coconut water for the company, which will be

increased from 218,000 tons per year to 310,000 tons per year, in order to support the rising demand

for coconut water products. This investment will support the growth of the company continuously in

the future.

9. Source of funds for investment

The company will pay for the assets with internal cash flow around 20% of the total investment and

will loan from the financial institutions around 80% of total investment. The company expects that

there will be no impact on the rights of company shareholders.
