We would like to inform you that the company has a net loss for the third quarter of the year 2023 amounting to Bht 1.02 million. The net profit decreased from last year by Bht 4.54 million or 128.86 percent. This is due to the details as following:

## Sales and Services Income

Sales and service income for this year decreases in the amount of Bht 31.17 million, or 19.62 percent from the same quarter of last year. This is due to the delay with project delivery.

## Gross Profit

Gross profit is Revenue deducted from cost of goods sold which include raw material, direct labor and overhead. In Third quarter of the year 2023 our gross profit decrease of baht 2.96 million or 5.87 percent due to low sales income. Gross margin from sales and services increases from 31.73 in the third quarter of the year 2022 to 37.16 in this quarter due to the high margin small project and the cost control.

## Selling and Administrative Expenses

Selling and Administrative expenses mainly are Delivery and Installation Cost, Employee expense, Rental, Utilities expense, Marketing expense and Depreciation and Amortization expense. In the third quarter of the year 2023 Selling expenses decrease from 24.48 million baht in the third quarter of the year 2022 to 24.20 million baht in this quarter due to the lower sale income. But the percentage to Revenue, the percentage is increase from 15.41% in the third quarter of 2022 to 18.94% in this quarter. Administrative expenses increase from 21.57 million baht in the third quarter of the year 2022 to 24.30 million baht in this quarter. And the percentage to Revenue also increase from 13.57% in the third quarter of 2022 to 19.03% in this quarter due to the increase of cost of expenses. Anyhow, the company is continuously strictly control of all expenses.
