Management Discussion and Analysis

Executive Summary Quarter 3/2023 Performance

Wattana Karnpaet Public Company Limited ("Company") reported the total income in Quarter 3 Year 2023 to be Baht 133.293 million, decreased from Quarter 3 Year 2022 Baht 143.772 million or decreased by 7.29 per cent. The income comprises of the hospital's income of Baht 131.276 million in 2023, decreased from Baht 141.761 million or decreased by 7.40 per cent from last year. And the other income of Baht 2.017 million in 2023, increased from Baht 2.011 million from last year, or decreased by 0.30 per cent. The decrease in income was due to the decrease in number of in-patients with Covid-19 which was in an outbreak high number in 2022.

In Quarter 3/2023, the Company has EBITDA of Baht 38.181 million, which decresed from Baht 51.859 million in the same quarter last year, or increased by 26.38 per cent.

The Company reported net profit of Baht 21.113 million, decreased from Baht 33.712 million, or decreased by 37.37 per cent from the same quarter last year, or the net profit of 2.11 Baht per share.

Cost and Expenses

In Quarter 3/2023, the Company has the total cost and expenses of Baht 106.027 million, increased from Baht 100.812 million of last year, or a 5.17 per cent increased from last year.

The cost of hospital operations in Quarter 3/2023 was Baht 91.212 million, increased from Baht 78.378 million of last year, or increased by 16.37 per cent. The increase in cost of operations was mainly due to the expanding the medical services, depreciation, and increasing costs of utilities.

The administrative expenses in Quarter 3/2023 was Baht 14.815 million, decreased from Baht 22.434 million of last year, or decrease of 33.96 per cent.
