The separate financial statements for the third quarter of 2023 of the Company increased by 36.806 million baht in net profit compared to the third quarter of 2022, representing a 189.42% increase. Total revenue increased by 51.221 million baht, or 110.72%, while total expenses increased by 24.010 million baht, or 47.19%. As a result, the Company's operating results for the third quarter of 2023 increased by 36.806 million baht in net profit.

The consolidated financial statements for the third quarter of 2023, the net profit increased by 37.663 million baht from the third quarter of 2022, representing a 188.72% increase. The total revenue increased by 51.219 million baht, or 111.05%. The total expenses increased by 23.223 million baht, or 45.42%. As a result, the consolidated financial statements for the third quarter of 2023 showed a net profit of 37.663 million baht

The causes of increases or decreases in the separate financial statement of the company:

- 1. The improvement of various crisis situation has resulted in an increase in service income to 51.221 million baht in the third quarter of 2023, representing an increase of 110.72% compared to the third quarter of 2022.
- 2. Total expenses in the third quarter of 2023 increased by 24.010 million baht, representing an increase of 47.19% compared to the third quarter of 2022. This is due to:

- 2.1 An increase in cost of services of 23.650 million, representing an increase of 66.89% compared to the third quarter of 2022. This is an increase in proportion to the increase in service revenue, in accordance with normal business operations.
- 2.2 An increase in administrative expenses of 0.360 million, representing an increase of 2.32% compared to the third quarter of 2022. This is an increase in general administrative expenses due to the rising price level.
- 2.3 A decrease in financial costs of 5.962 million baht, representing a decrease of 51.58% compared to the third quarter of 2022. This is a decrease due to the repayment of loans for various investment projects previously.
- 2.4 A decrease in the loss on impairment of financial assets of 3.437 million baht in the third quarter of 2023. This is in accordance with Thai Financial Reporting Standard (TFRS) No. 9.
- 2.5 A decrease in income tax expenses of 0.024 million baht, representing a decrease of 19.05% compared to the third quarter of 2022. This is due to the company's compliance with Thai Financial Reporting Standard (TFRS) No. 12., Re: The Income Tax Expense.
- 3. PT. Thai NDT Indonesia (debtor) is undergoing a business review to review the value of liabilities and assets, as well as to consider the scope of business and investment size, together with both private and government partners, for the possibility of receiving future work.

For the reasons mentioned above, the profit (loss) of the third quarter of 2023 was in line with such amount.
