Subject: Notification of additional investment in the subsidiary company

As AIRA Property Public Company Limited ("AIP"), the subsidiary of AIRA Capital Public Company Limited ("Company" / "AIRA") (The Company is the shareholder in the proportion of 59.99%) has subscribed new shares in the amount of 4,000,000 shares at the price of 10 baht per share, totaling a share value of 40,000,000 baht to the existing shareholders in proportion (in case there is a fraction of a share, the fraction of that share shall be rounded) with the schedule to subscribe for the new ordinary shares and pay for the shares within November 24, 2023 at 15.00 hrs. The objective is to support the continued business expansion and to provide working capital for AIP.

The Board of Directors meeting of AIRA no.5/2023 held on November 14, 2023, has been resolved to approve the additional investment in AIP, in this regard the Company would like to inform you about the details of the additional investment in AIP as follows:

- 1. Transaction date: Within November 24, 2023
- 2. The proportion of the purchase of subscribing new ordinary shares: The Company has approved the purchase of the subscription of new ordinary shares in an amount not exceeding 3,200,000 shares, valued at 32,000,000 baht, which is the purchase of shares in proportion to the Company's shareholding of 2,399,999 shares, valued at 23,999,990 baht and has subscribed for shares in excess of the rights allocated. In the case that other shareholders do not

exercise their rights in an amount not exceeding 800,001 shares, equivalent to 8,000,010 baht.
