Management Discussion and Analysis

For the third quarter ended 30 September 2023 in the separate financial statements, the Company generated net profit of 26.87 million baht. In the consolidated financial statements, the Company had net profit of 22.69 million baht, increasing by 4.16 million baht over the same period of the previous year, because the Company managed to improve the efficiency of production planning and control. However, there were rises in production costs such as labour costs, electricity bills, and an allowance for obsolete inventory. Distribution costs and administrative expenses increased, for example, personnel expenses, legal fees for export business, foreign exchange loss, loss on sale of asset, and an allowance for doubtful accounts according to the Thai Financial Reporting Standards 9 (TFRS9).

The Company's total revenues increased by 16.52 million baht or 4.81 percent, compared to the same period of the previous year. Export sales rose steadily, but there was a decline in domestic sales of communication racks, cabinets, enclosures, agricultural machine tools & equipment, and assembly parts.

In Q3/2023, the Company had a share of loss from investment in Nitto Kogyo BM (Thailand) Company Limited (NBT), an associated company, amounted to 4.06 million baht. Still, NBT has recognized the depreciation of plant and equipment.

As of 30 September 2023, the Company had total assets of 1,601.60 million baht, increasing by 176.72 million baht, compared to 31 December 2022, primarily due to trade receivables, plant and equipment, and inventories. The Company's total liabilities increased by 132.38 million baht because of a rise in trade payables and loans from financial institutions for the construction of new factory in Free Zone. The Company's Debt to Equity (D/E) ratio was 0.76.
