The operating results for 3Q23 and 9M23 mainly derived from the oil tanker fleet transportation service business.

Total revenues

For 3Q23, the Company generated total revenue from fleet transportation service business for petroleum and chemical products, composed of Baht 184.4 million, Baht 0.1 million, and Baht 0.9 million from the freight charges, gain on exchange rate, and other revenues, respectively.

For 9M23, the Company generated total revenue from fleet transportation service business for petroleum and chemical products, composed of Baht 525.1 million, Baht 8.3 million, and Baht 2.6 million from the freight charges, gain on exchange rate, and other revenues, respectively.

For 3Q23, the total freight charges of the Company was Baht 184.4 million, an decreased of Baht 34.5 million compared to 3Q22 or decreased 15.8%.

This was caused by an decreased in the domestic and international freight charges, this was due to

- Domestic freight charges had decreased 0.4% due to
 - In 3Q23, there was an increase of revenue of two vessels, namely the newly acquired "V.L.
 24", and the V.L. 23 that had adjusted the strategy of fleet management from the international voyage to domestic voyage.
 - In 3Q23, there was 1 vessel in the dry-docking for maintenance, V.L. 20 and 1 vessel for repair, V.L. 17.
- International freight charges had decreased 52% due to the number of vessels of the international fleet has decreased, as a result of the management had adjusted the strategy of fleet management for one vessel (V.L. 23).

For 9M23, the total freight charges of the Company was Baht 525.1 million, an decrease of Baht 32.3 million compared to 9M22 or increased 5.8%.

Gain on exchange rate

For 9M23, gain on exchange rate of the Company was Baht 8.3 million, an increase compared to 9M22 due to the Company recognized the realized gain on exchange rate from the acquisition of a new vessel, which paid to the foreign currency by using of forward contract.

Cost of freight

For 3Q23, cost of freight of the Company was Baht 165.9 million, an decrease of Baht 4.2 million compared to 3Q22 or decreased 2.5% and for 9M23, cost of freight of the Company was Baht 463.2 million, an decrease of Baht 1.2 million compared to 9M22 or decreased 0.3% according to decreased freight charges.

Gross profit

For 3Q23, gross profit of the Company was Baht 18.5 million or gross profit margin of 10.0% of total freight charges, an decrease of Baht 30.3 million compared to 3Q22 or decreased 62.1%. This was a result of the total freight charges to increase.

Income for the period

For 3Q23, income for the period of the Company was Baht 1.5 million, an decrease of Baht 26.6 million compared to 3Q22 and for 9M23, income for the period of the Company was Baht 5.5 million, an decrease of Baht 16.4 million compared to 9M22.

Assets

As of 30 September 2023, the Company reported total assets of Baht 1,929.8 million, an increase of Baht 47.7 million compared to 31 December 2022 or increased 2.5% due to

- Decrease in other current financial assets amounted to Baht 75.5 million because of the Company sold such financial assets to payment for acquisition of a new vessel in whole amount.
- Vessels and equipment has increased in the amount of Baht 125 million because of in the 2Q23
 the Company purchase a new vessel in the amount of Baht 180 million and there is depreciation
 of vessel and equipment contained in the account.

Liabilities

As of 30 September 2023, the Company reported total liabilities of Baht 933.6 million, an decrease of Baht 10.7 million compared to 31 December 2022 or decreased 1.1% due to

 Decrease in the total interest-bearing debt amounting to Baht 5.5 million, in caused of the borrowing of loans from a financial institution for the purchase of a new vessel of Baht 115.0 million and the repayment of loans from financial institutions which is in accordance with the agreed contract of Baht 119.3 million.

Shareholders' Equity

As of 30 September 2023, the Company reported total shareholders' equity of Baht 996.2 million, an increase of Baht 58.4 million compared to 31 December 2022 or increased 6.2% due to there was an income for the year 9M23 amounting to Baht 5.5 million and in 3Q23 he Company had received the increase capital in the amount of Baht 52.8 million from the exercise of warrants.
