

The main reason is coupled with the current economic recession. As a result of this, brings to the decreased of sale order quantity of this product.

Gross Profit

Gross Profit for the Third Quarter ended 30 September 2023 was 202.22 million Bath, It was decreased 22 percent from the same period last year. Because the production cost of the marketed product group has a high cost. In addition, the company has organized a free product promotion in the sale of a set of products to stimulate consumer purchases. As a result, gross profit has decreased.

Selling Expenses

Selling expenses for the Third Quarter ended 30 September 2023 were 178.14 million Baht. It was decreased 82.55 million Baht or 32 percent from the same period last year, mainly due to the company cut down the advertising and promotion expenses such as television program broadcast time rent, advertising production cost, actor salary and promotion cost. In line with the current market situation.

Administrative Expenses

Administrative expenses for the Third d Quarter ended 30 September 2023 were 67.64 million Baht. It was Increase 3.65 million Baht or 6 percent due to increased depreciation and asset disposal losses

Net Profit

The Company has net loss for the Third Quarter ended 30 September 2023 was 33.92 million Baht, It was decreased of 23.70 Million Baht or equals to 41 percent from the same period last year.
