For the first nine months of 2023, the Company had the total revenue of 396.64 million baht. The revenue came from IOM water management services, accounted for 98.34%, revenue from engineering services, accounted for 1.09% and other income accounted 0.57% of total revenues.

- 1. Revenue from Services for the first nine months of 2023 decreased as compared to the same period last year.
  - 1.1 The revenue from IOM services decreased by 73.69 million baht, because of 2 parts, 1) Revenue from Waste Water Treatment Systems, Din Daeng wastewater treatment plant according revenue from maintenance service completed on last year. 2) Revenue from Drainage Tunnel according reduced rainfall.

- 1.2 The revenue from engineering services decreased from the same period of the previous year by 65.11 million baht, according to 2 projects that already completed in 2022 which were 1) Thonburi waterwork Filter Press Project and 2) Department store located in Samut Prakan. Moreover, Minburi project most of the revenue was already recognized in the first nine months of 2022.
- 3. Gross Profit for the first nine months of 2023 was 93.36 million baht accounted for 23.67%.
- 4. Other income increased by 1.94 million baht from interest income.
- 5. Financial expenses decreased by 3.77 million baht, from repayment of long term loan.

As of November 30, 2023, the Company had total assets of 684.55 million baht, which decreased by 122.30 million baht or 15.16% from the last period of the previous year. The Company's total assets decreased from 1.) Account receivable and 2.) Cash decreased from repayment loans to financial institute.

As of November 30, 2023, the Company had total liabilities of 98.09 million baht, which decreased by 148.08 million baht or 60.15% from the same period of the previous year. the Company's total liabilities decrease from repayment to short-term and long-term loans.

As of November 30, 2023, the total shareholders' equity of the company was 586.46 million baht increased by 25.78 million baht or 4.60% from net profit.
