

# Information Memorandum on the Acquisition and Disposition of Assets Wyncoast Industrial Park Public Company Limited

The Board of Director's Meeting of Wyncoast Industrial Park Public Company Limited (the "Company") No.12/2023 on December 28, 2023 has resolved the following resolutions:

- (a) The Company to approve the disposal of Advance Eastern Engineer Company Limited ("the Subsidiary Company") to Mr. Kongpob Maneenuch ("the Buyer"), totaling 1,295,000 ordinary shares, par value of Baht 10 per share, accounting for 28.73 percent of the registered capital. The shares will be disposed at Baht 0.01 per share, totaling Baht 12,952.14 as Information Memorandum part 1.
- (b) The Company to approve the disposal of Advance Eastern Engineer Company Limited ("the Subsidiary Company") to Mr. Kongpob Maneenuch ("the Buyer"), totaling 1,846,385 ordinary shares, par value of Baht 10 per share, accounting for 40.96 percent of the registered capital. The shares will be disposed at Baht 0.01 per share, totaling Baht 18,463.85 as Information Memorandum part 2.
- \*\* The Company and its subsidiary company have acquired the ordinary share of Advance Eastern Engineer Company Limited in accordance with the judicial order of Central Bankruptcy Court (the Company has reported the information memorandum to SET on April 4, 2023). Currently, Advance Eastern Engineer Company Limited has submitted for dismission plan and is waiting for the order.

The disposal of subsidiary company's ordinary shares in Clause (a) and Clause (b) above are regarded as disposal of assets pursuant to the Notification of the Capital Market Supervisory Board No. Tor Jor 20/2551 Re: Rules on Entering into Material Transactions Deemed as Acquisition or Disposal of Assets and the Notification of The Board of The Stock Exchange of Thailand Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition and Disposition of Assets B.E. 2547 dated October 29 2004.

## PART 1 Disposal of Wyncoast Industrial Park Public Company Limited's subsidiary company's ordinary share

The essence of the transaction are as follows.

#### 1. Date of the Transactions

The Company has agreed and engaged the Memorandum of Understanding of Buying and Selling subsidiary company's share with the Buyer on December 28, 2023 upon the condition to settle the payment within 60 days after the judicial order to dismiss the plan.

### 2. Parties and the involvement with the Company

Seller : Wyncoast Industrial Park Public Company Limited

Buyer : Mr. Kongpob Maneenuch

Mr. Kongpob Maneenuch has no related person or undertaking to the Company or the Company's subsidiaries whatsoever.

### 3. Nature of the transaction

The Company will dispose 1,295,214 ordinary shares of Advance Eastern Engineer Company Limited, representing 28.73 percent of the registered capital and paid-up share. The ordinary shares will be disposed at Baht 0.01 per share, totaling Baht 12,952.14. The Company will complete the transfer of share's ownership within 60 days from the date of payment.

### 4. The calculation of the particulars

The Company has received payment for disposal subsidiary's share from the Buyer with Baht 12,952.14.

### 7. Value of the asset disposed

The 1,295,214 shares of Advance Eastern Engineer Company Limited represents 28.73 percent of the registered capital and paid-up shares at Baht 0.01 per share, totaling baht 12,952.14.



### 8. The criteria used to determine the value of consideration

The agreed price between the Company and the Buyer has been negotiated to acquire and dispose 1,295,214 ordinary shares of Advance Eastern Engineer Company Limited has been engaged at Baht 0.01 per share, calculated from the financial statements of the subsidiary company as of December 31, 2022 which is higher than book value.

### 9. Prediction of benefits to the Company

The Company believes that the disposal of Advance Eastern Engineer Company Limited's ordinary share will generate benefits to overall of the Company's year 2023 consolidate financial statement since the financial statement of Advance Eastern Engineer Company Limited posted accumulated loss over its equity and has liability more than assets. If the Company still holds the subsidiary's share, it will be negative caused to the Company's financial statement in the future. Accordingly, the Company believes that this transaction is appropriate and beneficial to the Company.

### 10. Plans to use the proceeds from the sale.

The Company will receive payment of Baht 12,952.14 from disposal of subsidiary shares to pay all related fee and use as working capital.

### 11. Opinions from the board of directors of the particulars

Board of Director has expressed opinions that the Company should dispose the investment in Advance Eastern Engineer Company Limited since the Company acquires the shares from the judicial order of Central Bankruptcy Court, the financial statement of Advance Eastern Engineer Company Limited has been required to consolidate with the Company's financial statement as the subsidiary company as it is found out that its financial statement would cause a certain risk in the future if the Company maintains its holding and status, accordingly. Thus, the Board of Director has agreed with the transaction.

## 12. Opinions from the Auditing Officer and the Board of Directors having opinions different from others.

The Audit Committee has agreed that the transaction is more appropriated and generates benefit to the Company than maintaining its holding and status of Advance Eastern Engineer Company Limited since its financial statement posted accumulated loss over equity and liability more than assets, negative DE ratio and negative book value. If the Company keeps the investment, it would be affected to overall Company's consolidated financial statement, respectively.

However, the disposal of Advance Eastern Engineer Company Limited's 1,295,214 shares, equivalent to 28.73% of total registered capital and paid up at higher price than its book value which states the fair value and benefit to the Company. The Audit and Risk Management Committee has same opinion with the Board of Director's opinion, respectively.

Chachoengsao Power Company Limited is the subsidiary of Wyncoast Industrail Park Public Company Limited, holding 87.85%, The Company has agreed and engaged the Memorandum of Understanding of Buying and Selling subsidiary company's share with the Buyer on December 28, 2023 upon the condition to settle the payment within 60 days after the judicial order to dismiss the plan.

### 2. Parties and the involvement with the Company

Buyer : Chachoengsao Power Company Limited

Seller : Mr. Kongpob Maneenuch

Mr. Kongpob Maneenuch has no related person or undertaking to the Company or the Company's subsidiaries whatsoever.

### 3. Nature of the transaction

Chachoengsao Power Company Limited will dispose 1,846,385 ordinary shares of Advance Eastern Engineer Company Limited, representing 40.96 percent of total registered capital and paid up. The agreed acquired price is Baht 0.01 per share, equivalent to Baht 18,463.85. The share transfer will be completed within 60 days after received the payment from the buyer.

The agreed price between the Company and the Buyer has been negotiated to acquire and dispose 1,846,385 ordinary shares of Advance Eastern Engineer Company Limited has been engaged at Baht 0.01 per share, calculated from the financial statements of the subsidiary company as of December 31, 2022 which is higher than book value.

### 9. Prediction of benefits to the Company

Chachoengsao Power Company Limited (subsidiary) believes that the disposal of Advance Eastern Engineer Company Limited's ordinary share will generate benefits to overall of its financial statement 2023 and the Company's consolidate financial statement since the financial statement of Advance Eastern Engineer Company Limited posted accumulated loss over its equity and has liability more than assets. If Chachoengsao Power Company Limited (subsidiary) still holds the subsidiary's share, it will be negative caused to financial statement in the future. Accordingly, Chachoengsao Power Company Limited (subsidiary) believes that this transaction is appropriate and beneficial.

### 10. Plans to use the proceeds from the sale.

Chachoengsao Power Company Limited (subsidiary) will receive payment of Baht 18,463.85 from disposal of subsidiary shares to pay all related fee and use as working capital.

### 11. Opinions from the board of directors of the particulars

Board of Director has expressed opinions that Chachoengsao Power Company Limited (subsidiary) should dispose the investment in Advance Eastern Engineer Company Limited since Chachoengsao Power Company Limited (subsidiary) acquires the shares from the judicial order of Central Bankruptcy Court, the financial statement of Advance Eastern Engineer Company Limited has been required to consolidate as the subsidiary company. Moreover, it is found out that its financial statement would cause a certain risk in the future if Chachoengsao Power Company Limited (subsidiary) maintains its holding and status, accordingly. Thus, the Board of Director has agreed with the transaction.

## 12. Opinions from the Auditing Officer and the Board of Directors having opinions different from others.

The Audit Committee has agreed that the transaction is more appropriated and generates benefit to Chachoengsao Power Company Limited (subsidiary) than maintaining its holding and status of Advance Eastern Engineer Company Limited since its financial statement posted accumulated loss over equity and liability more than assets, negative DE ratio and negative book value. If Chachoengsao Power Company Limited (subsidiary) keeps the investment, it would be affected to overall consolidated financial statement, respectively.

However, the disposal of Advance Eastern Engineer Company Limited's 1,846,385 shares, equivalent to 40.96% of total registered capital and paid up at higher price than its book value which states the fair value and benefit to the Company. The Audit and Risk Management Committee has same opinion with the Board of Director's opinion, respectively.
