Sales and Services Income

Sales and service income for this year increased in the amount of Baht 27.13 million, or 4.45 percent from the last year. The main increased in sales was the renovated office project and the sales and the project delivery is now trend to back to normal schedule.

Gross Profit

Gross profit is Revenue deducts cost of goods sold which include raw material, direct labor and overhead. In 2023, the company has gross profit increase of baht 52.74 million or 29.85 percent. Moreover, gross margin from sales and services increases from 29.00 percent in 2022 to 36.05 percent in 2023 due to the increase of sales and selling price and the slightly down trend of cost of steel and wood after covid which are one of our main materials and the reduce of obsolete stock plan was improved.

Selling and distribution expenses and Administrative Expenses

Selling and distribution expenses and administrative expenses mainly are Employee expense, Rental, Utilities expense, Marketing expense and Depreciation and Amortization expense. Selling and Administrative expenses increase from Baht 185.16 million in 2022 to Baht 201.89 million in 2023 or 9.04 percent that increased in line with sales. Moreover, the percentage of the Selling and distribution expenses and Administrative to Sale increased from 30.37 in 2022 to 32.03 in 2023.
