The Increase / Decrease of the Consolidated financial performance were by the results of the followings:-

1. Revenue from operations of the Company and its Subsidiaries in 2023 increased from THB 229.63 million in 2022 to THB 305.79 million, an increase of 33.17%. The increase in revenue came from the following businesses: Non-destructive Testing (NDT) services, Electron Beam Services, Electricity Sales, and Electrical Installation Contracts. NDT services generated revenue of THB 205.33 million in 2023, an increase of 15% compared to 2022. Electron beam services generated revenue of THB 33.32 million in 2023, an increase of 505% compared to 2022.

2. Cost of services increased from THB 161.06 million in 2022 to THB 200.64 million in 2023, an increase of 24.58%. The Financial Costs in the year 2023 has decreased by 5.67 million baht or 13.34% compared to 2022. This is a decrease due to the repayment of loans for various investment projects previously.

The Company had a gross profit from operations of THB 109.07 million, up from THB 74.55 million in 2022, an increase of 3. 46.30%. This was due to the increase in revenue from NDT services and Electron Beam services.

4. Administrative expenses in 2023 were THB 66.01 million, down from THB 78.93 million in 2022, a decrease of 16.36%. This was due to better cost control.

5. In 2023, the Company recorded impairment losses of THB 255.73 million and THB 139.03 million for non-financial assets and financial assets, respectively, this is in accordance with Thai Financial Reporting Standard (TFRS) No. 9. The impairment of non-financial assets was due to delays in the operation of the Tachileik power plant in Myanmar by the reasons of the political situation and unrest in the country, as well as the expected credit loss which may appear to the oversea business partners.

In 2023, the Company had a net loss of THB 366.741 million, an increase of 551.61% compared to 2022. The main factor was the impairment of assets, which did not result from normal operations. For the reasons mentioned above, the profit (loss) of the financial statements for the year 2023 was in line with such amount.
