Revenues For 2022, the company and subsidiary's total revenue was Baht 819.22 million decreasing by Baht 103.24 million or equivalent to 11.19%, compared with 2022. The majority cause was the decreased revenues from transportation service, the revenues comprising:

For 2023, the company and subsidiaries' revenues resulting from transportation service, assets rental, the driver's behavior monitoring service, and the interest in car leasing agreements, and chemicals product sales, were Baht 792.43 million, comprising with:

- Revenues from transportation service which is the company's major income were Baht 650.12 million or 74.35% of total revenue decreasing from the previous year by Baht 41.04 million or equivalent to 6.31%, as the short-term contract with international clients has terminated. However, the company has a new contract with domestic clients and internationally and increased Revenues from Rail transportation service.
- Revenues from other services, which comprises asset leasing, the driver's behavior monitoring service, and the interest in car leasing agreements, were Baht 77.55 million, equivalent to 9.47% of total revenue, increasing from the previous year by Baht 13.37 million or equivalent to 20.83 % as the subsidiary company has a new contract with a repeat customer.
- Revenues from sales were Baht 105.80 million, equivalent to 12.91% of total revenue, decreasing from the previous year by Baht 61.67 million or decreased by 36.82 %, because of the client's decreased sale-order quantity.

Total cost for 2023, the company and subsidiary's total cost was Baht 564.68million or 68.93 % of total revenue. The total cost decreased from 2022 by Baht 90.13 million or decreased by 13.77% The cost of sales decreased related to total revenue.

Gross profit for 2023, the company and subsidiary's gross profit was Baht 227.76 million in total, or equivalent to 27.80% of total revenue increasing from the previous year by Baht 0.79 million, or equivalent to 0.35 %, because of the total cost of the company and its subsidiary decreasing.

The Company and subsidiaries' selling, and **Selling and Administrative expenses** administrative expenses of 2023 were Baht 141.67 million decreasing from the previous year by Baht 10.50 million or decreasing equivalent to 6.90%.

Interests & Income Tax expenses The Company and subsidiaries' interests and corporate income tax expenses for 2023 were Baht 25.87 million or equivalent to 3.16% of total revenue.

Net profit The Company and its subsidiaries' net profit for 2023 was Baht 87.00 million or equivalent to 10.62 % of total revenue, the net profit decreased from the previous year by Baht 10.86 million or increased equivalent to 13.65%. because a short-term transportation contract with an international client has terminated and the subsidiary company has decreased revenues from sales. however, The Subsidiary company has more Service contracts but it can't compensate for decreased Revenues therefore The Company and the subsidiaries have a decrease in net profit.
