Service income

Service income in 2023 is similar to the previous year. which revenue from the company's services It is income from 67 projects with a value of 313.65 million Baht and income from 62 projects proposed for work in 2023 with a value of 98.04 million Baht.

Income from filming and produce video

Income from filming and video production in 2023 decreased from the previous year by 3.27 million Baht or 0.95 percent from the same period last year. Decreased from revenue from production of Virtual Realit (VR) work that will be delivered in 2022.

Cost of Services

The Company and its subsidiaries had service costs decreased from the previous year in the amount of 2.67 million Baht or 0.87 percent from the same period of the previous year due to the following reasons:

- Cost of external expert consultants according to the nature of project-specific work decreased from the previous year by 23.18 million Baht.
- Cost of transportation for work and miscellaneous expenses decreased by 4.74 million Baht
- But there are still costs for salary and employee benefits that increased by 15.87 million Baht.

Administrative expenses

The company and its subsidiaries had administrative expenses increased by 6.71 million Baht or 7.83

percent from the same period last year, due to

increased from information service fees and administrative service fees for the accounting and

human resources departments in the amount of 3.15 million Baht

Increased from the cost of training seminars and employee knowledge development in the

amount of 2.36 million Baht.

Other expenses

In 2023, the company and its subsidiaries There were other expenses increased from the previous year

in the amount of 22.37 million Baht or 100 percent from the same period of the previous year. The reason is from

the company. Acknowledged damages from lawsuits in the amount of 19.68 million baht, which the company

estimated that The cost of such damages will be compensated from the professional damage insurance policy

contract, which is in the process of evaluating compensation from the insurance company and because until the

date of publication of these financial statements The Company has not yet received a letter of compensation

according to the policy that the Company has made with an insurance company. Therefore, the Company will

record compensation from the company. Insurance is another income in the period when the confirmation letter is

received.

Net profit (loss) and net profit (loss) margin

For the year ending December 31, 2023, the Company and its subsidiaries had a net operating loss of

18.69 million Baht, a decrease from the previous year's period of 40.41 million Baht or a decrease of 47.15 percent

from other expenses that increased as received. mentioned above and from the share of losses from investments

in 2 associated companies of the company in the amount of 17.40 million Baht.

As of December 31, 2023, the Company and its subsidiaries had total liabilities of 306.50 million Baht, a decrease of 39.45 million Baht from 2022, due to

- Decreased from repayment of short-term loans from financial institutions in the amount of 14.96 million Baht.
- Decreased from repayment of some bonds in the amount of 40 million Baht.
- Increased from estimates of other current liabilities damages from lawsuits in the amount of
 19.68 million Baht

Shareholders' equity

As of December 31, 2023, the Company and its subsidiaries had shareholders' equity of 311.11 million Baht, a decrease of 19.79 million Baht from 2022, due to

- Decreased from dividend payment of 8.60 million Baht.
- Decreased from operating results with a net loss of 18.19 million Baht.
- Increase in other comprehensive profits from the remeasurement of employee benefits in the amount of 11.31 million Baht
