Performance analysis description

In the 4th quarter ended December 31, 2023 The Company had a net profit of baht 10.406 million, an increase from the previous year of baht 3.370 million or 47.90 %, with the following main factors:

- 1. Increase revenue sales from the previous year about for 1.43% mainly due to sales increase from new customer and existing customer increased order volume.
- 2. Decrease in cost of raw material prices during the 4th quarter of 2023 and compared to the 4th quarter of 2022, the average purchase price of raw materials per quarter decreased by 7.3%.

<u>FY2023</u> The company had a net profit of baht 54.616 million, an increase from the year 2022 of baht 32.601 million or 148.09% was mainly due to an increase in sales volume and production efficiency was increase which impact cost down.
