# 1. Sales and service income

Performance for the year ended December 31,2023. The company has income from sales and services in the amount 646.48 million baht increased from year 2022 Amount 40.87 million baht or an increase of 6.75 percent and operating results for the 4th quarter for the 3-month period ended December 31, 2023. The company has income from sales and service amounted to173.48 million baht or and increase from the same period of 2022 in the amount of 7.63 million baht or an increase of 4.60 %. The increase in sales and service revenue came mainly from the Process Management and Pipeline product line and Energy and Utilities Product Group which is a new product group added in 2023.

In addition, the company still has products and services. that have received purchase orders and are in the process of being gradually delivered (Backlog) according to the following table

### 2. Other income

For the year ended December 31, 2023. The company has other income of 5.24 million baht, a decrease from 2022 of 0.85 million baht or a decrease of 13.96 % and for the 4th quarter, 3- month period ended December 31, 2023 The company had other income of 1.35 million baht, decreased from the same period of 2022. quantity 1.29 million baht or a decrease of 48.86 % due to decreased promotional income.

#### 3. Cost of sales and cost of services

For the year ended December 31,2023. The company has costs of sales and services of 480.67 million baht, an increase from 2022 of 42.94 million baht or an increase of 9.81 %. And for the 4th quarter, 3- month period ended December 31, 2023, the company has costs of sales and services. The amount of 129.29 million baht increased from the same period of 2022 by 12.32 million baht or an increase of 10.53 %, which is in the same direction as sales and service income. However, when comparing the proportion of cost of sales. and service with income from sales and services and found that The proportion of cost of sales increased from 72.28 % of revenue in 2022 to 74.35 % in 2023, the reason is that manufacturers have increased product costs in some product groups.

### 4. Distribution costs and administrative expenses

For the year ended December 31, 2023. The company has distribution costs and administrative expenses of 115.64 million baht, a decrease of 3.88 million baht or 3.25 % from 2022. And for the 4th quarter, 3- month period ending December 31, 2023, the company has costs of Distribution and administrative expenses amounted to 29.63 million baht, a decrease of 3.93 million baht from the same period of 2025, or a decrease of 11.71 %. However, when comparing the proportion Distribution costs and administrative expenses With income from sales and services, it was found that the proportion of expenses, etc., decreased from 19.73 % of income in 2022 to only 17.89 % of income in 2023, showing that the company can control and manage expenses efficiently.

### 5. Share of profits (losses) belonging to the parent company

For the year ended on December 31, 2023. The company has a net profit (loss) of only 22.11 million baht, a decrease from 2022 of 9.81 million baht or a decrease of 30.73 %. And for the 4th quarter, 3- month period ended December 31, 2023, the company has a net profit (loss) of 22.11 million baht. Separate businesses amounted to 2.44 million baht, a decrease from the same period of 2022 in the amount of 14.98 million baht or a decrease of 85.99 % due to receiving dividends from associated companies in the amount of 10.75 million baht in the 4th quarter of 2022.

In addition, for the year ended December 31, 2023, the Company also recognized net profit of Utility Business Alliance Public Company Limited ("UBA") at a rate of 28.67 %, amounting to 20.51. million baht, a decrease from 2023, which recognized the net profit of Utility Business Alliance Public Company Limited ("UBA") at a rate of 39.99%, amounting to 6.15 million baht, or a decrease of 23.07%.

From the performance mentioned above and the recognition of profits from subsidiaries and associated companies. As a result, the company total comprehensive profit for 2023 attributable to the parent company total 61.43 million baht, a decrease from 2022 of 5.32 million baht or a decrease of 7.97 %.
